## **ANNOUNCEMENT POWER GENERATION FOR DECEMBER 2022**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited\* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for December 2022 on a consolidated basis amounted to 7,029,229 MWh, representing a year-on-year increase of 7.32% compared with the corresponding period of 2021. In particular, the wind power generation registered an increase of 14.44%, the coal power generation registered a decrease of 6.67%, and other renewable energy power generation registered a decrease of 57.91%. As of 31 December 2022, the total power generation of the Group for 2022 amounted to 70,633,024 MWh, representing a year-on-year increase of 11.61% compared with the corresponding period of 2021. In particular, the wind power generation registered an increase of 13.66%, the coal power generation registered a decrease of 1.89%, and other renewable energy power generation registered an increase of 44.87%.
