Remarks: The total number of issued shares as at 28 February 2023 was 24,994,569,223 (comprising 4,588,846,425 Class A ordinary shares and 20,405,722,798 Class B ordinary shares).
Xiaomi Corporation (the "Company") purchased a total of 16,000,000 class B ordinary shares during the period from 7 December 2022 to 29 December 2022 (the "Shares Repurchased") on the Stock Exchange. All the Shares Repurchased were subsequently cancelled on 22 March 2023 and the number of class B ordinary shares in issue was reduced by 16,000,000 shares as a result of the cancellation accordingly. Upon cancellation of the Shares Repurchased, the weighted voting rights ("WVR") beneficiaries of the Company, simultaneously reduced their WVR in the Company proportionately by way of converting their class A ordinary shares into class B ordinary shares on a one-to-one ratio pursuant to Rule 8A.21 of the Listing Rules, such that the proportion of shares carrying WVR of the Company shall not be increased, pursuant to the requirements under Rules 8A.13 and 8A.15 of the Listing Rules.
