PROFIT ALERT AND REDUCTION IN NET LOSS

This announcement is made by BGMC International Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that based on its preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 September 2024 (the “**Reporting Period**”) and information currently available to the management, the Group is expected to record an unaudited net loss attributable to shareholders of the Company of approximately RM8.3 million, as compared to net loss attributable to shareholders of the Company of RM14.1 million for the six months ended 30 September 2023 (the “**Corresponding Period**”).

The reduction in net loss for the Reporting Period was mainly attributable to, among others, (i) increase in revenue due to substantial work progress on a newly secured project; (ii) lower gross loss recognised due to less project cost overruns; and (iii) lower finance costs incurred in the Reporting Period.

Shareholders and potential investors should note that the information contained in this announcement is only based on a preliminary assessment by the Board with reference to the information currently available to the Board and it has not been audited by the auditor of the Company, nor has been reviewed or confirmed by the audit committee of the Company. As at the date of this announcement, the Company is still in the process of finalising its consolidated interim results for the Reporting Period, which are subject to adjustment and final review by the Company.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
