UNAUDITED OPERATING FIGURES FOR DECEMBER 2024

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the twelve months ended 31 December 2024. For the twelve months ended 31 December 2024, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB345 million, the aggregate contracted gross floor area was 53,412 sq.m. and the average selling price was approximately RMB6,467.1per sq.m..
