Prudential plc (the "**Company**") announces today it has purchased the following number of its ordinary shares of 5 pence each through Barclays Capital Securities Limited ("**Barclays**") on the London Stock Exchange in accordance with the authority granted by shareholders at the Company's 2024 Annual General Meeting (the "**Purchase**"). The Purchase was effected in accordance with the agreement entered into with Barclays, as announced on 5 December 2024.
