# BUSINESS UPDATE IN RELATION TO THE MEMORANDUM OF UNDERSTANDING ON A STRATEGIC COOPERATION

This announcement is made by Envision Greenwise Holdings Limited (the "Company") on a voluntary basis to inform its shareholders and potential investors of the latest development of the Company.

#### MEMORANDUM OF UNDERSTANDING

(a) Industry information sharing: The Parties shall regularly share their respective interpretations and the latest updates on the global battery recycling policy trends, industry insights, technological breakthroughs, and other policies, working together to address the challenges and opportunities brought about by such policy changes;

- (b) Business cooperation with complementary strengths: Leveraging CRR International's strengths in resource coordination and market expansion, the Company's global service network resources, and Brunp's advanced recycling technology and operational experience, the Parties will collaborate in the areas of technology, equipment, and talent, actively exploring a mutually beneficial business cooperation model; and
- (c) Overseas regional cooperation exploration: Exploring the possibility of cooperation in selected overseas regions to jointly establish and operate battery recycling collection points and related facilities, leveraging each Party's advantages for resources sharing and complementary strengths, and promoting international business expansion.

It has developed a vertically integrated battery industry chain, and is reputed as a key partner of top international automobile enterprises. Contemporary Amperex Technology Co., Limited is a company listed on the Shenzhen Stock Exchange (300750.SZ).
