Letter to New Registered Shareholders - Notification of Publication of Circular in respect of Major Transaction dated 26 May 2025 (the "Current Corporate Communication") and Election of Language and Means of Receipt of Corporate Communications

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), the articles of association of the Company and the Companies Ordinance, Chapter 622 of the Laws of Hong Kong, the Company is permitted to make available the following options for you to choose for receipt of future Corporate Communications*:

- (1) to access all future Corporate Communications on the Company's website at www.melco-group.com (the "Company's website") in place of receiving printed copies; or
- (2) to receive by post the printed English version of all future Corporate Communications only; or
- (3) to receive by post the printed Chinese version of all future Corporate Communications only; or

If the Company does not receive a duly completed and signed Reply Form from you or receives no response from you indicating that you object to receiving Corporate Communications in electronic form on the Company's website on or before 24 June 2025, you are deemed to have consented to receive Corporate Communications in the manner as set out in option (1) above, until you inform the Company otherwise by reasonable notice in writing (not less than 7 days) to the Company's share registrar, Tricor Investor Services Limited at 17th Floor, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by email to melco200-ecom@vistra.com. In that event, when the Company makes a Corporate Communication, the Company will send you a notification that the Corporate Communication has been made available on the Company's website. The notification will be sent to you by email (if you have provided an email address) or by post to you at your address as it appears on the Company's register of members maintained by the Company's share registrar (if you have not provided an email address).

You may change your choice of language (English and/or Chinese) and means of receiving Corporate Communications (in printed form or through the Company's website), free of charge, at any time by reasonable notice in writing (not less than 7 days) to the Company's share registrar, Tricor Investor Services Limited at the above-mentioned address or by email to melco200-ecom@vistra.com, notwithstanding any wish to the contrary you have previously conveyed to the Company or the Company's share registrar. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications by electronic means but for any reason have difficulty in receiving or gaining access to Corporate Communications electronically, the Company will upon your written request send the Corporate Communications to you in printed form free of charge.

Please note that printed copies of the English and Chinese versions of all future Corporate Communications will be available from the Company and the Company's share registrar on request.
