VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE

This announcement is made by Hong Kong Robotics Group Holding Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) on a voluntary basis. The board (“**Board**”) of directors of the Company (the “**Director(s)**”) would like to update the shareholders and potential investors of the Company on the latest business development of the Group.

ENTERING INTO A PROCUREMENT COOPERATION AGREEMENT

The Board is pleased to announce that on 2 July 2025, Hong Kong Robotics Limited (“**Hong Kong Robotics**”) as vendor, a non-wholly owned subsidiary of the Company entered into a procurement cooperation agreement (the “**Procurement Cooperation Agreement**”) with Tonwell Security Limited* (通宏護衛有限公司) as purchaser (“**Tonwell Security**”) in relation to the procurement of embodied intelligent security robots.

Pursuant to the Procurement Cooperation Agreement, Hong Kong Robotics and Tonwell Security agreed, among others, that the procurement quantity of the embodied intelligent security robots will be not less than 1,000 units in Hong Kong within two years starting from the date of the Procurement Cooperation Agreement and the embodied intelligent security robots will be priced at RMB300,000 per unit with an aggregated contract sum of RMB300,000,000. The first batch of procurement is expected to be 50-100 units of embodied intelligent security robots and the subsequent batches will be 100 units per delivery.

Tonwell Security is a member of The Hong Kong Security Association, providing security services to public and private sectors in Hong Kong.

To the best of the Directors' knowledge, information and belief, each of Tonwell Security and its ultimate beneficial owners is independent of and not connected with the Company and its connected persons and not a connected person of the Company.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the securities of the Company.
