| 1. <u>Constitution</u> | <u>組成</u> |
| 1.1 The Committee is established pursuant to a resolution passed by the Board at its meeting held on 5 September 2007. | 本委員會是按董事會於 2007 年 9 月 5 日所舉行之會議通過決議成立的。 |
| 2. <u>Membership</u> | <u>成員</u> |
| 2.1 The Chairman of the Committee shall be the chairman of the Board or an independent non-executive director. | 委員會主席須由董事會主席或獨立非執行董事出任。 |
| 2.2 A majority of the member of the Committee shall be the independent non-executive directors with at least one member of a different gender. | 委員會大部份之成員必須是獨立非執行董事，成員中至少一名成員為不同性別的董事。 |
| 2.3 The company secretary of the Company shall be the secretary of the Committee. | 本公司的公司秘書為委員會的秘書。 |

| 3. <u>Proceedings of the Committee</u> | <u>會議程序</u> |
| 3.1 Notice: | <u>會議通告：</u> |
| (a) Unless otherwise agreed by all the Committee members, a meeting shall be called by at least seven days’ notice. | (a) 除非獲委員會全體成員同意，召開委員會會議須發出最少七天的通告。 |
| (b) A Committee member may and, on the request of a Committee member, the secretary to the Committee shall, at any time summon a Committee meeting. Notice shall be given to each Committee member in person orally or in writing or by telephone or by email or by facsimile transmission at the telephone or facsimile or address or email address from time to time notified to the secretary by such Committee member or in such other manner as the Committee members may from time to time determine. | (b) 任何委員會成員或委員會秘書（應委員會成員的請求時）可於任何時候召集委員會會議。召開會議通告必須按該成員不時通知秘書的電話號碼、傳真號碼、地址或電子郵箱地址以親身口頭或以書面形式、或以電話、電子郵件、傳真或其他委員會成員不時議定的方式向各委員會成員發出。 |

- (c) Any notice given orally shall be confirmed in writing as soon as practicable and before the meeting.

- (d) Notice of meeting shall state the time and place of the meeting and shall be accompanied by an agenda together with other documents which may be required to be considered by the members of the Committee for the purposes of the meeting.
- (d) 會議通告必須說明開會時間、地點，並須附上議程及委員會成員就會議可能須考慮的其他文件。

3.2 **Quorum:** The quorum of the Committee meeting shall be two members of the Committee and a majority of which shall be the independent non-executive directors.

3.3 **Frequency:** Meetings shall be held at least once a year to review, formulate and consider the nomination procedures as regards the appointment, reappointment and removal of directors (the “Directors”) of the Company, their implementation during the year and to make recommendations to the Board on candidates for appointment as Directors.

4. **Written resolutions**

4.1 Written resolutions may be passed by all Committee members in writing.

5. **Alternate Committee members**

5.1 A Committee member may not appoint any alternate.

6. **Authority of the Nomination Committee**

提名委員會的權力

6.1 The Committee may exercise the following powers:

- (a) to seek any information it requires from any employee of the Company and its subsidiaries (together, the “Group”) and any professional advisers in order to perform its duties, to require any of them to prepare and submit reports and to attend Committee meetings and to supply information and address the questions raised by the Committee;
- (a) 向本公司及其附屬公司(統稱「本集團」)的任何僱員及任何專業顧問徵求資料、要求彼等任何人士編製及提供報告、出席委員會會議以及提供所需資料及解答委員會問題；
- (b) to review the performance of the Directors and the independence of independent non-executive Directors in relation to their appointment or re-appointment as Directors;
- (b) 對於董事的委任或重新委任，評審董事的表現及獨立非執行董事的獨立性；

| <p>(c) to obtain, at the Company's expenses, outside legal or other independent professional advice on or assistance to any matters within these terms of reference, including the advice of independent human resource consultancy firm or other independent professionals, and to secure the attendance of outsiders with relevant experience and expertise at its meetings if it considers this necessary. 9. Continuing application of the articles of association of the Company

- 9.1 The articles of association of the Company regulating the meetings and proceedings of the Directors so far as the same are applicable and are not replaced by the provisions in these terms of reference shall apply to the meetings and proceedings of the Committee.

10. Powers of the Board

- 10.1 The Board may, subject to compliance with the articles of association of the Company and the Listing Rules (including the Corporate Governance Code set out in Appendix C1 to the Listing Rules or if adopted by the Company, the Company's own code of corporate governance practices), amend, supplement and revoke these terms of reference and any resolution passed by the Committee provided that no amendments to and revocation of these terms of reference and the resolutions passed by the Committee shall invalidate any prior act and resolution of the Committee which would have been valid if such terms of reference or resolution had not been amended or revoked.

本公司組織章程的持續適用

本公司組織章程對董事會會議及其程序的規定，在其適用及職權範圍條文未有取代情況下，適用於委員會的會議及程序。

董事會權力

由董事會在不違反本公司組織章程及上市規則的前提下(包括上市規則之附錄 C1《企業管治守則》或本公司所採納其適用及自行制定的企業管治常規)，修訂、補充及廢除本職權範圍所有條文及委員會通過的任何決議，惟修訂及廢除本職權範圍條文及委員會通過的決議，並不會令到倘該等職權範圍條文或決議並無修訂或廢除原應生效的任何早前行動及決議作廢。
