This document is the Share Redemption Election Form referred to in the circular to shareholders of TechStar Acquisition Corporation ("**TechStar**") dated November 12, 2025 (the "**Circular**") for use by the TechStar Class A Shareholders to make their election in respect of the Share Redemption. Terms defined in the Circular have the same meanings in this Share Redemption Election Form.

Prior to the EGM to approve the De-SPAC Transaction, TechStar will provide TechStar Class A Shareholders with the opportunity to elect to redeem all or part of their holdings of TechStar Class A Shares for an amount per TechStar Class A Share equal to the Share Redemption Price. You should refer to "Important Notice to TechStar Shareholders and Actions to be Taken – B. TechStar Redemption Right" in the Circular for further details. If you are in any doubt about this Share Redemption Election Form or as to the action to be taken, you should consult your licensed securities dealer or other registered dealer in securities, bank manager, solicitor, professional accountant or other professional adviser.

You should complete this form to make your election in respect of the Share Redemption. You **do not** need to complete this form if you do not wish to have any TechStar Class A Shares redeemed. You should return the completed Share Redemption Election Form to the Hong Kong Share Registrar, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong by no later than 9:00 a.m. on Monday, December 1, 2025 (or such other date and time as may be notified to the TechStar Class A Shareholders by TechStar on the respective websites of the Stock Exchange and TechStar).

If the De-SPAC Transaction is not completed, TechStar will not redeem any TechStar Class A Shares and all Share Redemption requests will be canceled. Redeeming TechStar Shareholders are strongly recommended to vote FOR the resolutions to be proposed at the EGM, even if you intend to elect to redeem some or all of your TechStar Class A Shares. A form of proxy for use at the EGM is enclosed with copies of the Circular sent to the Registered Shareholders. If you are a Registered Shareholder, whether or not you are able to attend the EGM, you are strongly urged to complete and sign the form of proxy in respect of the EGM, in accordance with the instructions printed on it.

If you are a Beneficial Owner whose TechStar Class A Shares are deposited in CCASS and registered under the name of HKSCC Nominees Limited, do not complete this form. You should contact your broker, custodian, nominee or other relevant person who is, or has in turn deposited such TechStar Class A Shares with, a CCASS Participant regarding instructions to be given to such persons.

If you wish to elect to have your TechStar Class A Shares redeemed, it is your responsibility to satisfy yourself as to the full observance of the laws and regulations of the relevant jurisdictions in connection with the Share Redemption (including but not limited to the obtaining of any governmental or other consent which may be required or the compliance with other necessary formalities and the payment of any transfer or other taxes due by you in respect of the Share Redemption in such jurisdictions). Any election for the Share Redemption by you will be deemed to constitute a representation and warranty from you to TechStar that you have the full, power and authority, and have observed and are permitted under all applicable laws and regulations, to elect to have your TechStar Class A Shares redeemed pursuant to the Share Redemption and that you have obtained all requisite governmental, exchange control or other consents and have made all requisite registration and filing in compliance with all necessary formalities and regulatory or legal requirements and have paid all taxes and duties or other required payments due from you in connection with such election in any relevant jurisdiction, and that such election shall be valid and binding in accordance with all applicable laws and regulations.
