**Net Generation of Subsidiary Power Plants Increased by 7.0%,
among which Subsidiary Wind Farms Increased by 16.4%,
Photovoltaic Plants Increased by 55.5%**

Total net generation of subsidiary power plants in December 2025 increased by 6.6% year on year to 21,921,954 MWh, among which, subsidiary wind farms increased by 21.6% year on year to 5,361,475 MWh, subsidiary photovoltaic plants increased by 58.0% year on year to 1,150,980 MWh.

Total net generation of subsidiary power plants for 2025 increased by 7.0% year on year to 226,789,826 MWh, among which, subsidiary wind farms increased by 16.4% year on year to 53,702,309 MWh, subsidiary photovoltaic plants increased by 55.5% year on year to 13,202,002 MWh.
