## **VOLUNTARY ANNOUNCEMENT – BUSINESS UPDATE RELATING TO AI SERVER BUSINESS**

This is a voluntary announcement made by Karrie International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”). The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to provide an update for the Group’s AI Server business.

Since Q3 2025, the Group has received server chassis orders from one of the leading AI companies, which has completed chassis design development, passed the customer sample validation, and is ready to enter mass production. Meanwhile, the Group has also successfully secured customer demand for design and prototype on the next-generation AI architecture, including network switch chassis, AI compute chassis and server racks, with deliveries expected to commence gradually throughout 2026. These initiatives demonstrated the Company’s proven expertise to provide a complete mechanical solution supporting client’s next-generation AI platforms architecture.

For the update on ASIC (Application-Specific Integrated Circuit) customers, the Group initiated mass production in Q3 2025, and achieved a rapid ramp-up in deliveries of its ASIC related server chassis in the second half of 2025. The end customer of this ASIC enclosures is an American leading technology corporation. The Company expects its customers’ demand remain strong throughout 2026 for production capacity in both China and Thailand plants. Furthermore, the construction of the new production plant on land purchased in Thailand by the Group has commenced. It is expected that the first phase of the production facility will be put into operation by the end of this year. The Group continues to improve the operational efficiency of its plants in both China and Thailand to meet the rapidly growing demand for orders from existing and new customers.

This announcement is made by the Company on a voluntary basis to keep shareholders and potential investors of the Company informed of the latest business development of the Group.
