## VOLUNTARY ANNOUNCEMENT LATEST BUSINESS DEVELOPMENTS

This announcement is made by Unisound AI Technology Co., Ltd. (the “**Company**”) on a voluntary basis to inform the shareholders and potential investors of the Company of its latest business developments.

The Company recently entered into a cooperation agreement with the People's Government of the Guangxi Zhuang Autonomous Region (“**Guangxi**”) to jointly establish the China-ASEAN Artificial Intelligence Application Cooperation Center. Capitalizing on Guangxi's unique geographical advantages and its well-established policy and industrial platforms, the parties aim to build a cross-border industrial ecosystem featuring “R&D in Beijing/Shanghai/Guangzhou + Integration in Guangxi + Application in ASEAN.” Positioning itself in Guangxi and targeting the ASEAN market, the Company will leverage its strengths in technology, talent, resources and application scenarios to build a leading innovation hub for artificial intelligence.

This cooperation represents the Company's first strategic partnership with a provincial-level (autonomous region-level) people's government, signifying that the Company's core artificial intelligence technology capabilities, industry application experience and brand influence have received comprehensive recognition at the provincial (autonomous region) government level. Such cooperation will help the Company establish a sustainable and replicable business synergy mechanism at the regional level, laying the foundation for subsequent large-scale implementation across multiple scenarios and departments, and further expand the Company's business growth potential.

Currently, the Company has established a wholly-owned subsidiary, Unisound (Guangxi) Intelligent Technology Co., Ltd. (雲知聲（廣西）智能科技有限公司), in Nanning, Guangxi, to serve as its ASEAN headquarters. The Company is actively assembling an R&D and operations team. With “AI + Healthcare” as a breakthrough point, and through collaboration between Beijing and Guangxi, the integration of medical and industrial sectors, as well as coordination among medical insurance, healthcare administration and medical management, the Company intends to build its ASEAN headquarters into a core base for its integrated innovation and overseas business expansion. By integrating cutting-edge technologies and high-end talent resources from Beijing, Shanghai, and Guangzhou, the Company aims to create a “high-end, inclusive, and cost-effective” smart healthcare

system covering all aspects of clinical services, medical insurance settlement, and healthcare administration and supervision, driving the intelligent upgrading of the comprehensive healthcare industry chain in Guangxi.

Leveraging its specialized large model technology capabilities and regional collaboration experience accumulated through years of deep engagement in the healthcare sector, the Company has successfully deployed relevant solutions in multiple provincial and municipal projects, laying a solid foundation for the rapid market entry and large-scale implementation of its business in Guangxi. Notably, the Company recently won the tender for China's first provincial-level large model project for medical insurance — the Jiangsu Provincial Medical Insurance Large Model Project, and concurrently won the tender for the relevant medical insurance AI agent application project. Through these projects, the Company is deeply involved in core processes such as the construction of the provincial medical insurance foundation models, the development of professional knowledge bases, and the construction and deployment of AI agent applications. The relevant solutions are built on the Company's independently pre-trained "UniGPT Large Model", covering medical insurance policy comprehension, intelligent business process optimization, and multi-scenario application support, and have formed a standardized and replicable technology and service system.

Meanwhile, using Guangxi as a foothold, the Company will actively promote resource sharing and technological exchanges with ASEAN enterprises, providing key support for expanding into the ASEAN market and enhancing the Company's international brand influence.
