### **INSIDE INFORMATION UPDATE ANNOUNCEMENT**

This announcement is made by Kunming Dianchi Water Treatment Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rules 13.09 and 13.51B(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 2 December 2025 (the “**Announcement**”) in relation to, among other things, the fact that the Company has been listed as a party subject to enforcement in a litigation. Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the Announcement.

Recently, the Company received a notice from the Chenggong District People’s Court (the “**Court Notice**”) stating that the Chenggong District People’s Court has seized the Company’s real estate properties located at 1/F of Building 5, 1-2/F of Building 10 and 1/F of Building 6, Zhongying Township, Guandu Town, Kunming, and has decided to proceed with a judicial auction. The Company and relevant rights holders are ordered to vacate the aforementioned properties by 10 February 2026. If there are any objections or claims of other rights such as leasehold interests, they must be submitted to the Chenggong District People’s Court within 15 days from the date of the Court Notice, together with relevant supporting evidence. Any submission made after this period will be deemed as no objection or no claim of rights.

Currently, the Company’s daily production and operations remain normal. The Company will continue to monitor developments related to this matter and will fulfill its information disclosure obligations in accordance with laws and regulations in a timely manner.
