Arrangement of Electronic Dissemination of Corporate Communications

Please note that such instruction shall be valid for one year starting from the receipt date of your instruction unless being revoked or superseded or changed by you (whichever is earlier) and will expire thereafter. Further request will be required if you prefer to continue receiving printed copy of future Corporate Communications (including Actionable Corporate Communications).
