**FURTHER DELAY IN DESPATCH OF CIRCULAR AND
REVISED EXPECTED TIMETABLE FOR RIGHTS ISSUE**

Reference is made to the announcements of Anchorstone Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) dated 14 January 2026 and 4 February 2026 in relation to, among other things, the proposed increase in authorised share capital, the proposed rights issue on the basis of four (4) rights shares for every one (1) existing share held on the record date on a non-underwritten basis and the set-off arrangement of the Company (collectively, the “**Announcements**”). Capitalized terms used herein shall have the same meanings as those defined in the Announcements unless the context otherwise requires.

FURTHER DELAY IN DESPATCH OF CIRCULAR

As set out in the Announcements, a circular (the “**Circular**”) containing, among other things, (i) further details of the Increase in Authorised Share Capital, the Rights Issue, the Set-off Arrangement; (ii) the letter of recommendation from the Independent Board Committee to the Independent Shareholders in respect of the Rights Issue and the Set-off Arrangement; (iii) the letter of advice from the Independent Financial Adviser to the Independent Board Committee and the Independent Shareholders in respect of the Rights Issue and the Set-off Arrangement; (iv) the notice convening the EGM; and (v) other disclosure requirements under the Listing Rules is expected to be despatched by the Company to the Shareholders on or before Monday, 16 February 2026.

As additional time is required for the Company to prepare and finalise the information to be contained in the Circular, the despatch of the Circular is expected to be postponed to a date on or before Monday, 2 March 2026.
