SUPPLEMENTAL ANNOUNCEMENT TO VOLUNTARY ANNOUNCEMENT ON STRATEGIC COLLABORATION

We refer to the announcement of Vobile Group Limited (the “**Company**”) dated 11 February 2026 (the “**Announcement**”). Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcement.

The Company wishes to supplement that the collaboration between the Group and Finloop will focus on two core directions: (1) Activating the value of the rights to IP revenue stream. Through Finloop’s successful experience in asset tokenization and global liquidity, combined with the Group’s extensive resources in the global IP industry, we will jointly explore ways to revitalize dormant IP assets, promote the efficient circulation of related assets under the regulatory framework, and inject new vitality into Hong Kong’s digital economy. (2) Strengthening the IP rights verification and valuation system. Relying on the Group’s core technological advantages in digital content rights verification and tracking, and combined with Finloop’s innovative technical solutions, we will build a full-process, traceable IP asset verification system to provide solid support for IP value assessment and establish scientific IP valuation standards. Ultimately, we will create an overseas RWA tokenization path for intellectual property based on regulatory compliance.

Finloop Finance Limited is a subsidiary of Finloop Finance Technology Holding Limited and holds licenses issued by the Securities and Futures Commission of Hong Kong under the Securities and Futures Ordinance to conduct Dealing in Securities (Type 1), Advising on Securities (Type 4), and Asset Management (Type 9) regulated activities. The Group works closely with Finloop to continue to strictly comply with all relevant laws and regulations.
