

VOLUNTARY ANNOUNCEMENT INCLUSION AS A CONSTITUENT OF HANG SENG COMPOSITE INDEX

This announcement is made by InSilico Medicine Cayman TopCo (the “**Company**”, together with its subsidiaries, the “**Group**” or “**InSilico Medicine**”) on a voluntary basis to inform the shareholders and potential investors of the Company about the latest business updates of the Group.

The board of directors of the Company (the “**Board**”) is pleased to announce that the Company has been selected and will be included as a constituent stock of the Hang Seng Composite Index (“**HSCI**”) by Hang Seng Indexes Company Limited, with effect from March 9, 2026.

Upon inclusion as a constituent stock of HSCI, the shares of the Company are expected to meet the inclusion criteria for trading via the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect. The Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect are channels for stock trading and investment between capital market investors in Hong Kong and Chinese Mainland.

The Board believes that the inclusion as a constituent stock of the HSCI reflects the high recognition of the international capital market on the Company’s industry position, business performance and value. It is expected to further improve the stock liquidity, broaden investor base with diversified shareholder composition, and promote the Company’s development in the long run.

The Board appreciates the continued support from the shareholders and investors of the Company.
