**COMPLETION OF RESTRUCTURING AGREEMENT OF**  
**FANTASIA HOLDINGS GROUP CO., LIMITED**  
**IN RELATION TO DISPUTE INVOLVING SHARES**  
**OF THE COMPANY**

Reference is made to the announcements of the Company dated 9 December 2021, 11 November 2025 and 5 January 2026 (the “**Announcements**”). Unless otherwise defined, capitalised terms used in this announcement shall have the same respective meanings as those defined in the Announcements.

The Company was informed that on 12 March 2026, completion of the transactions contemplated under the Restructuring Agreement had occurred. Upon completion of the transactions contemplated under the Restructuring Agreement, among others, (i) the Purchaser acquired approximately 21.97% of the issued shares of the Company; (ii) approximately 10.0% of the issued shares of the Company were transferred to an entity designated by TFISF (as effective enforcement of the purported security); (iii) Fantasia retains approximately 9.98% of the issued shares of the Company free from any purported security or other claim; and (iv) the Company ceases to be a subsidiary of Fantasia.

As at the date of this announcement, Ms. Zeng Jie, Baby indirectly owns approximately 59.99% of the issued shares of the Company through, among others, the Purchaser, Fantasia and Fatansy Pearl International Limited and she continues to be the majority shareholder of the Company.

Further details of the Restructuring Agreement are set out in the circular of Fantasia dated 24 February 2026.
