ANNOUNCEMENT IN RELATION TO A LEGAL PROCEEDING

This announcement is issued by FS.COM Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the inside information provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Board of Directors (the “**Board**”) of the Company hereby notifies the shareholders of the Company (the “**Shareholders**”) and potential investors that the Company has received a civil statement of claim from Huawei Technologies Co., Ltd. (the “**Plaintiff**”) alleging that the Company had infringed the Plaintiff’s trademark rights.

The Plaintiff’s principal claims are that the Company cease infringing the exclusive rights to the registered trademarks, and that the Company be responsible for compensating the Plaintiff.

The Company is currently conducting an assessment, seeking legal advice and engaging in active communication with the Plaintiff and its attorney. Based on the information currently available to the Company:

- I. the Company’s products do not infringe the Plaintiff’s trademark rights.
- II. Sales of the products as referred to by the Plaintiff in the statement of claim accounted for less than 0.2% of the Company’s operating revenue for 2025.

As the litigation is at an early stage, the Company will closely monitor its progress and effect on the Group. As at the date of this announcement, the Board confirmed that the litigation has no material adverse impact on the Group's normal operations and financial position, nor the Company's existing business and operations. Should there be any further material developments in relation to the litigation, the Company will issue a separate announcement in due course to provide an update on the situation.
