## **FINANCIAL AND BUSINESS REVIEW FOR THE FIRST QUARTER OF 2026**

The following description provides certain unaudited financial data relating to the operating performance of China Overseas Grand Oceans Group Limited (the “Company”) and its subsidiaries (collectively referred to as the “Group”) in the first quarter of 2026.

### **Financial Performance**

The Group’s revenue was approximately RMB5,520 million for the three months ended 31 March 2026, representing a decrease of 4.6% comparing with the same period last year, while the operating profit for the quarter was approximately RMB320 million, recording a decrease of 19.6% comparing with the same period last year.

### **Business Review**

In the first quarter of 2026, the Group and its associates and joint ventures (collectively, the “China Overseas Grand Oceans Series of Companies”) recorded contracted property sales of approximately RMB8,091 million for an aggregated area of approximately 690,600 square meters (“sq.m.”) sold, with year-on-year increase of 16.7% and 15.4% respectively. Also, as at 31 March 2026, the balance of preliminary sales pending the completion of sales and purchase agreements was approximately RMB534 million for an aggregated area of approximately 43,400 sq.m..

During this quarter, the Group newly acquired one parcel of land in Taizhou with the attributable gross floor area of approximately 86,700 sq.m. for the attributable land cost of approximately RMB287 million. As at 31 March 2026, the China Overseas Grand Oceans Series of Companies have a total landbank available to build gross floor area of approximately 11,992,100 sq.m. (of which, approximately 10,294,900 sq.m. are attributable to the Group, including the interests in associates and joint ventures) in the Chinese Mainland.

The Group would maintain a professional and prudent financial management of the financial resources and also continue to closely monitor the impacts from the external economic environment, volatility of exchange rate of Renminbi, merger and acquisition opportunities in the industry and national policy changes to the business operations in order to maximize its shareholders' returns in the long term.
