## Reminder letter regarding the Arrangements on Electronic Dissemination of Corporate Communications

Please note that both the English and Chinese versions of all future Corporate Communications will be available on the website of the Company at [www.kuaishou.com](http://www.kuaishou.com) and the website of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) at [www.hkexnews.hk](http://www.hkexnews.hk) (the “Website Version”) in place of printed copies. A notice of publication of the Website Version of Corporate Communications will not be sent by the Company and you need to proactively check the Company’s website and the Stock Exchange’s website to keep up with the publication of Corporate Communications.
