### **WITHDRAWAL OF STOP NOTICE IN RELATION TO TRANSFER OF CERTAIN SHARES**

This announcement is made by Contel Technology Company Limited (the “Company”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 3 March 2026 (the “**Announcement**”). Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Announcement.

The Board wishes to provide update on the development of the Stop Notice. On 27 April 2026, the Applicants and Mr. Lam made a joint application to the High Court by way of consent summons to, among other things, discontinue the action, and on 8 May 2026, the Court granted the order in terms of the consent summons. Accordingly, the action taken out by the Applicants has been discontinued and the Stop Notice is no longer in force.
