**SUPPLEMENTAL ANNOUNCEMENT
IN RELATION TO
DISCLOSEABLE TRANSACTION
ACQUISITION OF LISTED SECURITIES INVOLVING

UNDER GENERAL MANDATE**

Reference is made to the announcement of Add New Energy Investment Holdings Group Limited (the “**Company**”) dated 30 March 2026 in relation to, among other matters, the purchase of Sale Shares, being 37,700,000 HRZ Shares, by the Company from the Vendors pursuant to the Sale and Purchase Agreement (the “**Announcement**”). Unless otherwise defined herein, capitalised terms used herein shall have the same meanings as those defined in the Announcement.

The Board wishes to provide updated information in relation to Ocean Wing, being one of the Vendors.

As disclosed in the Announcement, Ocean Wing was beneficially and wholly owned by Ms. Cindy Deng (“**Ms. Deng**”). The Company has, since the signing of the Sale and Purchase Agreement, been notified that, pursuant to a sale and purchase agreement entered into between Ms. Deng as seller and Mr. Zhang Xianzhong (張先忠) (“**Mr. Zhang**”) as purchaser on 6 May 2026, the entire issued shares of Ocean Wing have been transferred by Ms. Deng to Mr. Zhang on the same date.

The Directors confirm that notwithstanding the abovementioned change in the ultimate beneficial owner of Ocean Wing, the parties to the Sale and Purchase Agreement remain unchanged. To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, (a) Mr. Zhang is a third party independent of the Company and its connected persons, and (b) there is no relationship between Ms. Deng and Mr. Zhang other than that arising from the abovementioned transfer of the shares of Ocean Wing.

This announcement is supplemental to, and should be read in conjunction with, the Announcement. The above additional information does not affect other details and content set forth in the Announcement. Save as disclosed herein, all other contents of the Announcement remain unchanged and continue to be valid for all purposes.
