VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING BY THE CONTROLLING SHAREHOLDER

This announcement is made by Softcare Limited (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company was informed by Ms. Yang Yanjuan (“**Ms. Yang**”), the non-executive Director and a controlling shareholder of the Company, that she had purchased a total of 876,400 ordinary shares of the Company in the open market at an average price of approximately HK\$25.63 per share, during the period from May 15, 2026 to May 22, 2026 (the “**Increase in Shareholding**”). From April 27, 2026 and up to the date of this announcement, Ms. Yang has purchased a total of 1,892,400 ordinary shares of the Company in the open market.

Ms. Yang is the spouse of Mr. Shen Yanchang (“**Mr. Shen**”), the founder, chairman of the Board, non-executive Director and a controlling shareholder of the Company. By virtue of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong), Ms. Yang and Mr. Shen are deemed to be interested in the shares of the Company held by each other. Immediately following the Increase in Shareholding, Ms. Yang and Mr. Shen are deemed to be interested in 333,631,900 ordinary shares of the Company, representing approximately 53.74% of the total issued shares of the Company as at the date of this announcement.

The Board believes that the Increase in Shareholding demonstrates the strong and sustained confidence of Ms. Yang towards the prospects and growth potential of the Company.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
