**FURTHER DELAY IN DESPATCH OF CIRCULAR
MAJOR AND CONNECTED TRANSACTION IN RELATION TO
ACQUISITION OF 25% ISSUED SHARE CAPITAL OF ASIAN
INTEGRATED CELL LABORATORY LIMITED INVOLVING ISSUE
OF CONVERTIBLE NOTES UNDER SPECIFIC MANDATE**

Reference is made to (i) the announcement of Zhong Ji Longevity Science Group Limited (the “**Company**”) dated 1 December 2025 and 2 April 2026 on the major and connected transaction in relation to acquisition of 25% issued share capital of Asian Integrated Cell Laboratory Limited involving issue of convertible notes under specific mandate; (ii) the announcements of the Company dated 22 December 2025, 16 January 2026, 9 March 2026, 8 April 2026 and 30 April 2026 in relation to the delay in despatch of circular (collectively, the “**Announcements**”). Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

As disclosed in the Announcements, a circular (the “**Circular**”) containing, among other things, (i) further information on the Target Company, the Sale and Purchase Agreement and the transactions contemplated thereunder; (ii) the recommendation from the Independent Board Committee; (iii) a letter of advice from the independent financial adviser to the Independent Board Committee and the Independent Shareholders in relation to the terms of the Sale and Purchase Agreement and the transactions contemplated thereunder; (iv) the financial information of the Target Company; (v) other information required under the Listing Rules; and (vi) notice of the SGM, was expected to be sent to the Shareholders on or before 29 May 2026 in compliance with the Listing Rules.

As additional time is required for the Company to prepare and finalise certain information to be contained in the Circular, it is expected that the date of despatch of the Circular will be postponed to a date on or before 30 June 2026.
