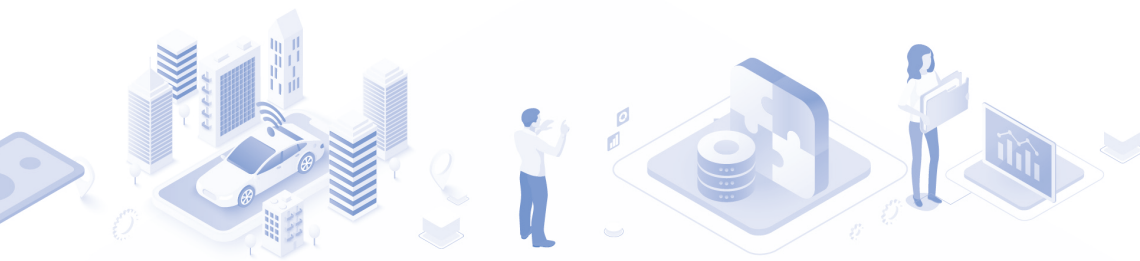

BUSINESS REVIEW

The Group mainly provides pledged vehicle monitoring services, automobile dealership operation management services and new automobile circulation services in China.

The Group has maintained its leading position in the pledged vehicle monitoring services market, primarily attributable to (i) the years of operation history and industry experience; (ii) its business coverage spanning 31 provinces and over 500 cities across China; and (iii) its establishment of a smart digital regulatory platform encompassing “personnel, vehicles, venues, and data”, leveraged on its core capabilities in “Internet of Things (IoT) + Big Data” and a nationwide localized network. The Group primarily provides pledged vehicle monitoring services to two categories of customers: (i) financial institutions that provide pledge financing for auto dealers’ vehicle purchases; and (ii) auto dealers engaged in the pledged vehicle business. This service integrates the capabilities of a “nationwide network, digital technology, and professional disposition”. In recent years, the Group has continuously developed its OCR-based video inventory auditing and AI-powered smart risk control systems, promoting the deep integration of technological innovation and scenario applications to enhance regulatory precision, operational efficiency, and risk identification capabilities. As of June 30, 2026, the Group provided pledged vehicle monitoring services to (i) approximately 167 branches of 16 commercial banks, including China’s “Big Six” national state-owned commercial banks and 10 joint-stock commercial banks; (ii) 20 automobile finance companies; and (iii) 17,376 automobile dealerships.

In April 2022, the Group started to provide operation management services to automobile dealerships by offering automobile dealership operational support, data system and managerial solutions. The Group has continuously upgraded its digital service capabilities. Through the development of an e-commerce mall transaction system, new and used car CRM systems, a used car inventory management system, and an independent low-code platform, the Group has achieved full business process coverage and integrated data operations, thereby enhancing decision-making efficiency and operational management capabilities. As of June 30, 2026, the Group managed a total of 64 automobile dealerships. During the Reporting Period, 4.4% of the Group’s revenue was generated from automobile dealership operation management services.

業務回顧

本集團主要於中國提供質押車輛監控服務、汽車經銷商運營管理服務及新汽車流通服務。

本集團在質押車輛監控服務市場保持領先地位，主要有賴於(i)多年經營歷史及行業經驗；(ii)業務覆蓋中國31個省份、500多個城市；及(iii)依託「物聯網(IoT)+大數據」核心能力及全國屬地化網絡，構建涵蓋「人、車、場、數據」的數智監管平台。本集團主要為兩類客戶提供質押車輛監控服務：(i)為汽車經銷商購車提供質押融資的金融機構；及(ii)從事質押車業務的汽車經銷商。該服務集「全國化網絡+數字化技術+專業化處置」能力於一體。近年來，本集團持續打造OCR視頻盤庫與AI智能風控體系，推動技術創新與場景應用深度融合，以提升監管精準度、運營效率及風險識別能力。截至2026年6月30日，本集團向(i)16家商業銀行（包括中國「六大」國有商業銀行及10家股份制商業銀行）的約167家分行；(ii)20家汽車金融公司；及(iii)17,376家汽車經銷商提供質押車輛監控服務。

於2022年4月，本集團開始通過提供汽車經銷商運營指導、數據系統及管理解決方案向汽車經銷商提供運營管理服務。本集團持續升級數字化服務能力，通過搭建商城交易體系、新車及二手車CRM系統、二手車進銷存體系與自主低代碼平台，實現全業務流程覆蓋及數據一體化運營，提升決策效率及運營管理能力。截至2026年6月30日，本集團管理合共64家汽車經銷商。於報告期內，本集團收入的4.4%產生自汽車經銷商運營管理服務。

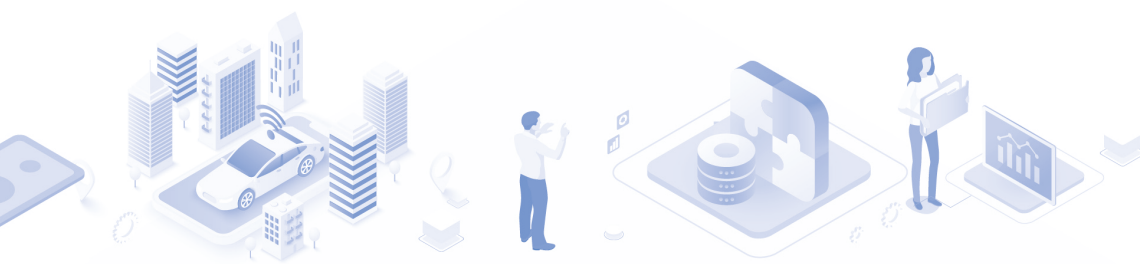
Concurrently, the Group has self-developed “9cheGO”, an automotive circulation supply chain service platform, dedicating itself to building China’s leading automotive transaction and circulation service platform. Driven by the dual engines of a “domestic channel network + overseas export synergy”, the platform connects upstream auto manufacturers with sunken county-level markets to explore new automotive retail ecological models. By empowering platform users with SaaS tools and integrating AI scenario applications with a smart transaction matching engine, the Group drives the formation of a more efficient closed-loop across resource allocation, transactions, management, settlement, and logistics, thereby assisting platform users in transitioning from traditional sales models to digital operations. Meanwhile, leveraging its self-developed AI platform, the Group focuses on core automotive sales scenarios within the field of smart marketing. It has constructed an automotive transaction vertical AI model based on authentic industry data, establishing a large-scale promotion and operational framework to enhance operational efficiency through technological innovation. As of June 30, 2026, the platform has served over 57,000 automobile dealerships, covering more than 1,000 county-level regions across China, with exclusive partnerships with over 1,400 merchants, demonstrating strong market penetration and growth potential.

By effectively integrating and leveraging its resource advantages, the Group has continuously enhanced its overall core competitiveness and achieved solid progress. During the Reporting Period, the Group focused on technology and innovation, continuously iterating and refining its business logic and commercial models, while persistently advancing the streamlining and optimization of business processes. Furthermore, the Group has further clarified its strategic objectives and implementation paths, thereby laying a solid foundation for subsequent business development.

與此同時，本集團自主開發「久車GO」汽車流通供應鏈服務平台，致力於建設中國領先的汽車交易及流通服務平台。平台以「國內渠道網絡+海外出口協同」雙輪驅動，連接上游汽車廠商及縣域下沉市場，探索汽車新零售生態模式。通過SaaS工具賦能平台用戶，並融入AI場景應用與智能交易匹配引擎，本集團推動資源、交易、管理、結算及物流環節形成更高效的閉環，助力平台用戶由傳統銷售模式向數字化運營轉型。同時，依託自研AI平台，本集團在智能營銷領域聚焦汽車銷售核心場景，基於真實行業數據構建汽車交易垂類AI模型，形成規模化推廣及運營體系，以技術創新提升經營效率。截至2026年6月30日，該平台服務超過57,000家汽車經銷商，覆蓋觸達中國超過1,000個縣級市場，獨家合作商戶超過1,400家，顯示出良好的市場滲透力及增長潛力。

通過有效整合及發揮資源優勢，本集團持續增強整體核心競爭力，並取得良好進展。報告期內，本集團聚焦科技及創新，不斷迭代完善業務邏輯及商業模式，持續推進業務流程精簡和優化，並進一步明確戰略目標及實施路徑，為後續業務發展奠定基礎。

FUTURE OUTLOOK

Looking ahead to the second half of the year, the Group will remain focused on three core business segments, namely pledged vehicle monitoring services, automobile dealership operation management services, and new automobile circulation services. The Group will prudently advance its business layout in response to market environments and customer needs, continuously enhance its core competitiveness, drive high-quality growth, and create sustainable value for all stakeholders, including shareholders, customers, and society at large.

In respect of pledged vehicle monitoring services, the Group will (i) always uphold the core philosophy of customers-oriented and consider maintaining core major customers as a top priority. By strengthening in-depth communication and cooperation with our major customers, we will understand their needs deeply and provide customized services to enhance customer satisfaction and loyalty; (ii) continuously enhance intelligent management level by carrying out comprehensive upgrades in terms of both hardware and software. Equipment such as barcode, OBD and password box will be upgraded to ensure the accuracy and security of data collection. At the same time, the VFS system will be reconstructed to optimize the system functions and operating procedures, enhance the user experience for both automobile dealers and financial institutions, and bolster the Company's competitiveness within the industry; and (iii) establish a dynamic risk assessment model. Through real-time monitoring and analysis of market data and business data, potential risks will be identified in a timely manner and corresponding response strategies will be formulated to provide partners with more secure and reliable services. In addition, the Group will strengthen the construction of the risk prevention and control system and improve the internal management system and processes to reduce the probability of risks from the source and safeguard the robust development of business.

未來展望

展望下半年，本集團將繼續專注於質押車輛監控服務、汽車經銷商運營管理服務及新汽車流通服務三大核心業務，並根據市場環境及客戶需求審慎推進業務佈局，持續提升核心競爭力，推動高質量增長，為股東、客戶及社會大眾等所有持份者創造可持續價值。

在質押車輛監控服務方面，本集團將(i)始終秉持客戶為先的核心理念，將維護核心大客戶作為重點工作。通過加強與大客戶的深度溝通與合作，深入了解其需求，提供更具針對性的服務，以增強客戶滿意度和忠誠度；(ii)持續提升智能化管理水平，通過全面升級硬件和軟件，對電子標籤、OBD及密碼箱等設備進行更新換代，確保數據採集的準確性和安全性。同時，本集團將重構VFS系統，優化系統功能和操作流程，提升汽車經銷商及金融機構的使用體驗，並增強本公司在行業內的競爭力；及(iii)建立動態風險評估模型，通過對市場數據、業務數據的實時監測和分析，及時發現潛在風險並制定相應應對策略，為合作夥伴提供更加安全可靠的服務。此外，本集團將加強風險防控體系建設，完善內部管理制度和流程，從源頭上降低風險發生概率，保障業務穩健發展。

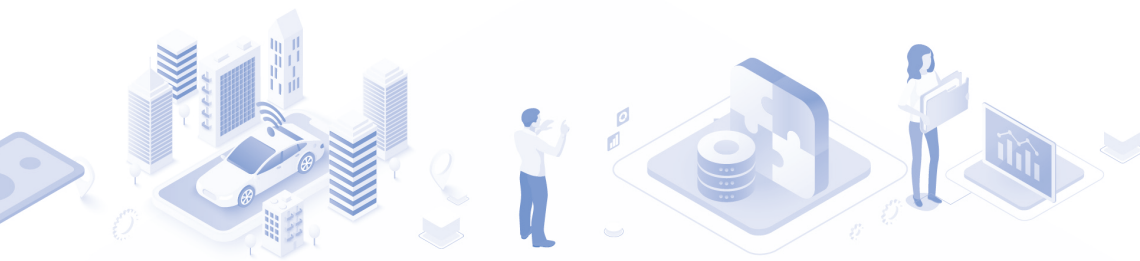
In respect of automobile dealership operation management services, the Group will (i) integrate industry resources to rapidly build up product systems and business models; (ii) strengthen talent acquisition, absorbing professionals with rich industry experience to build a team with pioneering spirit and entrepreneurial spirit, while continuously exploring and making breakthroughs with an entrepreneurial mindset; and (iii) strengthen its core service capabilities in areas such as operational guidance, data platforms, and management solutions, and leverage team experience alongside digital tools to provide customers with more comprehensive services and products.

In respect of new automobile circulation services, the Group will continue to drive the development of the automotive new retail, integrating resources of automotive dealers, suppliers, consumers and other partners. Leveraged on the Group's long-term accumulation in the automotive industry, the Group will further integrate its supply chain, international business, and automobile dealership operation systems to build diversified overseas sales resource and channel service capabilities. 9CheGO platform has established three major capability systems, including the user linking capability of "directly reaching the sinking markets in counties", the product capability of the automobile digital supply chain platform, and the data processing capability of real-time traceability. Relying on the Group's accumulation, advantageous resources and the capabilities of the online Internet trading platform within the automotive industry, 9CheGO platform will continuously promote the digital direct connection with county-level markets and end-users and enhance the efficiency of automobile sales. The platform will continue to deeply penetrate sinking markets, breaking through online and offline scenarios and forming a transaction closed-loop through the model of an 'online display and trading platform + offline county franchise channels', so as to establish a new identity of the automobile retail platform. The Group will further integrate local automobile resources and demand information, utilizing accurate market positioning and innovative marketing strategies to elevate the platform's popularity and influence in the sinking markets, thereby driving the sustainable development of its business. Meanwhile, the Group will continue to expand into overseas markets, exploring automobile export opportunities with OEMs to broaden market development space and continuously unlock growth momentum in overseas markets.

未來展望 *(續)*

在汽車經銷商運營管理服務方面，本集團將(i)整合行業資源，快速構建產品體系和商業模式；(ii)加強人才引進，吸納具備行業經驗的專業人才，搭建具有開拓精神及創業精神的團隊，以創業心態持續探索與突破；及(iii)強化運營指導、數據平台及管理解決方案等核心服務能力，依託團隊經驗及數字化工具，為客戶提供更全面的服務和產品。

在新汽車流通服務方面，本集團將繼續推動汽車新零售發展，整合汽車經銷商、供應商、消費者及其他合作夥伴資源。依託本集團在汽車行業的長期積累，本集團將進一步整合供應鏈、國際業務及汽車經銷商運營體系，構建多元化海外銷售資源及渠道服務能力。久車GO平台已形成三大能力體系，包括「直達縣域下沉市場」的用戶鏈接能力、汽車數字化供應鏈平台的產品能力，以及實時追溯的數據化處理能力。依託本集團在汽車行業的積累、優勢資源及互聯網在線交易平台能力，久車GO平台將持續推動縣域市場及終端用戶的數字化直連，提升汽車銷售效率。平台將持續深耕下沉市場，通過「在線展示交易平台+線下縣域加盟渠道」打通線上線下場景並形成交易閉環，構建汽車零售平台新身份。本集團將進一步整合本地車源及需求信息，運用精準市場定位及創新營銷策略，提升平台在下沉市場的知名度和影響力，推動業務可持續發展。同時，集團也將持續開拓海外市場，與主機廠商一同開拓汽車出口機會，拓寬市場發展空間，持續釋放海外市場增長動能。

The Group also plans to continue to deepen data products and services. Looking ahead, the Group will continue to accelerate the intelligent upgrade across all business segments through its dual-wheel drive strategy of AI and data. In the field of pledged vehicle monitoring services, the Group will focus on the construction of a standardized bank-enterprise direct connection platform, deep-dive into smart AI business applications, and construct a multidimensional risk control barrier, thereby solidifying the foundation of mutual trust between banks and enterprises to empower the high-quality development of the industry. In the field of automobile dealership operation management services, the Group will focus on full-lifecycle customer operations, advancing the construction of AI customer profiling, call centers, and quality inspection systems to build a customer-centric, omni-channel intelligent operational capability, unlocking the core value of AI for user experience, efficiency, and growth. The self-developed AI platform will further integrate frontier technologies, reshape business processes, break through data barriers, and empower intelligent decision-making, achieving an upgrade from an efficiency tool to a 'smart brain' to drive lean growth. In the field of smart marketing, with large-scale contract signing and in-depth operations as the core focus, the Group will promote product standardization and organizational synergy upgrades, crafting a technology-driven business segment characterized by "technology + operation" to cultivate a secondary growth space.

In addition, the Group will focus on promoting the integrated solution of "AI Camera + Smart Badge" tailored for original equipment manufacturers (OEMs). Based on computer vision technology, this solution enables the non-inductive collection of customer traffic and automatically statistics core data, helping OEMs enhance operational efficiency and management precision, while optimizing store operational models. The Group will also develop a brand-new smart badge product named "Lingzhi"—an AI-powered operational assistance system custom-built around automotive sales scenarios. The system is designed to feature capabilities including AI customer profiling, smart script quality inspection, sales competency assessment, real-time AI coaching, top-seller script accumulation and sharing, and full-process risk control logging. It can record sales receptions and test-drive processes, leveraging AI capabilities to assist in identifying customer needs, analyzing customer resistance, determining purchase intent levels, and performing sales process quality inspections. The Group expects that this solution will help drive the transformation of automotive sales management from experience-based judgment to a data-driven model.

未來展望 (續)

本集團亦計劃繼續深化數據產品及服務。展望未來，本集團將繼續堅持AI及數據雙輪驅動戰略，全面提速各業務板塊智能化升級。在質押車輛監控服務領域，本集團將聚焦銀企直聯標準化平台建設，深耕AI智能業務應用，構建多維風控屏障，築牢銀企互信基礎，賦能行業高質量發展。在汽車經銷商運營管理服務領域，本集團將聚焦客戶全生命週期運營，推進AI客戶畫像、呼叫中心及質檢系統建設，構建以客戶為中心的全域智能運營能力，釋放AI對體驗、效率與增長的核心價值。自研AI平台將進一步融合前沿技術，重塑業務流程，打通數據壁壘，賦能智能決策，實現由效率工具向「智慧大腦」升級，驅動精益增長。智能營銷領域將以規模化簽約與深度運營為主線，推動產品標準化及組織協同升級，打造「技術+運營」的科技型業務板塊，培育第二增長空間。

此外，本集團將重點推進面向主機廠商的「AI攝像頭+智能工牌」一體化解決方案。基於視覺識別技術，該方案可對客流進行無感採集並自動統計核心數據，幫助主機廠商提升運營效率與管理精度，優化門店運營方式。本集團亦將開發全新智能工牌產品「聆知」——一套圍繞汽車銷售場景打造的AI運營輔助系統。該系統擬具備AI客戶畫像、智能話術質檢、銷售能力評估、AI實時教練、銷冠話術沉澱共享、全程風控留痕等能力，能夠記錄銷售接待與試駕過程，並基於AI能力輔助完成客戶需求識別、客戶抗性分析、意向等級判斷及銷售流程質檢。本集團預期該方案將有助於推動汽車銷售管理由經驗判斷逐步向數據驅動轉型。

Through the aforementioned layout, the Group will continuously enhance the operational efficiency of the industry, supporting the digital transformation and high-quality development of China's automotive supply chain.

FINANCIAL REVIEW

Revenue

The Group's revenue generated from three business segments in terms of their nature, namely pledged vehicle monitoring services, new automobile circulation services and automobile dealership operation management services. The revenue decreased by RMB203.9 million or 29.3% from RMB696.7 million for the six months ended June 30, 2025 to RMB492.8 million for the Reporting Period, which was primarily attributable to the decrease of the revenue generated from new automobile circulation services which was principally due to the decline in automobile sales volumes mainly caused by adjustments of national vehicle subsidy policies.

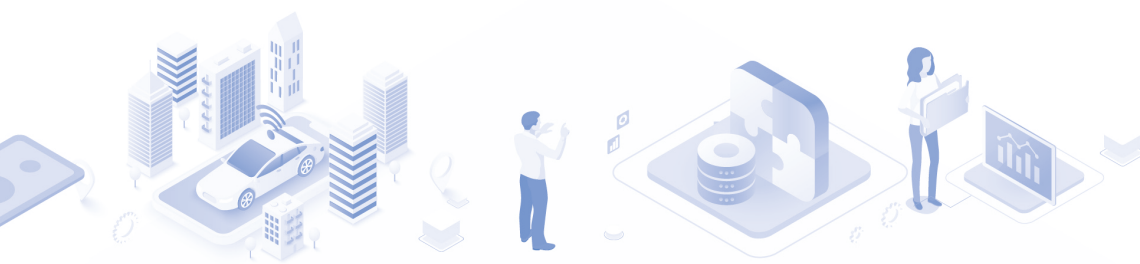

收入

For the Reporting Period, the revenue from the pledged vehicle monitoring services was RMB293.9 million, accounting for 59.6% of the Group's total revenue. The modest increase of 1.1% in revenue in the segment was primarily attributable to a rise in the number of service agreements, partially offset by a reduction in fees.

於報告期內，來自質押車輛監控服務的收入為人民幣293.9百萬元，佔本集團總收入的59.6%。該分部收入小幅增長1.1%主要歸因於服務協議數量增加，惟部分被費用調低所抵銷。

The Group typically enters into tripartite agreements with financial institutions and automobile dealerships for pledged vehicle monitoring services. Although the Group's pledged vehicle monitoring services are designed to help financial institutions manage secured financing provided to automobile dealerships, the Group considers the paying party under such tripartite agreements as the Group's customer, which may be either financial institutions or automobile dealerships, depending on the negotiation among the contracting parties, and the Group considers both financial institutions and automobile dealerships as the Group's users. The Group's revenue from pledged vehicle monitoring services was primarily derived from independent-third-party users.

For the Reporting Period, the revenue from the business of new automobile circulation services was RMB177.0 million, accounting for 35.9% of the Group's total revenue. The decrease of 53.2% in revenue in the segment was primarily due to the decline in automobile sales volumes, which was mainly caused by adjustments of national vehicle subsidy policies.

Cost of Sales

The Group's cost of sales mainly consists of (i) cost of inventories sold; (ii) subcontracting costs, representing service fees for third-party service providers for onsite supervision services in connection with the Group's pledged vehicle monitoring services; (iii) staff costs; (iv) logistics costs; (v) travel and entertainment expenses; (vi) technology and professional service fees; (vii) depreciation and amortization charges; and (viii) storage fee.

銷售成本

The onsite supervision services provided by independent third parties on a daily basis are basic and standard services.

For the Reporting Period, the total cost of sales of the Group was RMB342.9 million, which decreased by RMB201.5 million or 37.0% as compared to RMB544.4 million for the six months ended June 30, 2025. The decrease was primarily due to the decrease in the cost of inventories sold which mainly arose from the sales of Corolla 1.2T.

Gross Profit and Gross Profit Margin

The gross profit of the Group decreased by RMB2.4 million or 1.6% to RMB149.9 million for the Reporting Period from RMB152.3 million for the six months ended June 30, 2025 as a result of the net effect of the abovementioned factors for the decrease in revenue and cost of sales.

For the Reporting Period, the gross profit margin of the Group increased by 8.5 percentage points as compared with the same period during 2025, which was primarily due to the decrease in the new automobile circulation services, the gross profit margin of which was only 2.4%.

The gross profit margin of automobile dealership operation management services decreased by 12.2 percentage points due to the reduction of fixed costs is lower than the decrease in revenue.

The gross profit margin of new automobile circulation services was 2.4%. The gross profit margin of the business of new automobile circulation services increased slightly, driven by further business development.

Net Other (Losses)/Income

The Group's net other (losses)/income primarily consists of (i) other income from termination of other payables to customers; (ii) government grants; (iii) net exchange gains; (iv) net gains on financial investments measured at fair value through profit or loss; (v) provisions for litigations; and (vi) others.

The Group recorded a net other losses of RMB35.7 million for the Reporting Period, compared with a net other income of RMB3.0 million for the six months ended June 30, 2025, representing a significant swing of RMB38.7 million primarily caused by provisions for litigations. On August 10, 2026, a subsidiary of the Group received two first-instance judgments related to its pledged vehicle monitoring services. The court ruled that the subsidiary should compensate for losses amounting to RMB38.4 million. The subsidiary continues to appeal the judgements, but the outcome of the lawsuit has yet remained uncertain. On a prudential basis, the subsidiary has recognized provisions of RMB38.6 million in respect of above cases as of June 30, 2026, including the case acceptance fee of RMB0.2 million. For further details, please refer to the section “Material Legal Proceedings” below.

Other income from termination of other payables to customers relates to the derecognition of other payables to customer that primarily represent advance payment of pledged vehicle monitoring service received from automobile dealerships which had terminated their financing relationship with financial institutions or automobile dealerships whose obligation to pay service fee has been transferred to financial institutions during the service period, which are not directly related to the Group's operating activities.

Sales and Marketing Expenses

The sales and marketing expenses increased by RMB2.7 million or 55.1% from RMB4.9 million for the six months ended June 30, 2025 to RMB7.6 million for the Reporting Period. The increase in sales and marketing expenses was primarily due to an increase in the staff costs and an increase in the number of the employees associated with the business of new automobile circulation services.

Research and Development Expenses

The Group's research and development expenses increased by 48.2% from RMB11.0 million for the six months ended June 30, 2025 to RMB16.3 million for the Reporting Period. The increase was primarily due to an increase in the Group's staff costs and an increase in the number of the staff.

本集團的研發開支由截至2025年6月30日止六個月的人民幣11.0百萬元增加48.2%至報告期的人民幣16.3百萬元。該增加主要是由於本集團員工成本增加，以及員工數目增加。

The general and administrative expenses decreased by RMB4.3 million or 7.8% from RMB55.3 million for the six months ended June 30, 2025 to RMB51.0 million for the Reporting Period. The decrease in general and administrative expenses was primarily due to the decrease in the share-based compensation expenses.

Net Finance Expense/Income

For the Reporting Period, the Group recorded a net finance expense of RMB3.2 million, compared with a net finance income of RMB2.9 million for the six months ended June 30, 2025. This represents a year-on-year swing of RMB6.1 million, primarily driven by a decrease in the Group's interest income resulting from the decrease of cash and cash equivalents and an increase in the Group's interest expense on bank loans and other borrowings.

Income Tax Expense and Effective Tax Rate

The income tax expense decreased by RMB9.0 million or 53.3% from RMB16.9 million for the six months ended June 30, 2025 to RMB7.9 million for the Reporting Period. In December 2023, Changjiu Jinfu confirmed with related tax authority that it was entitled to be subject to an income tax rate of 15% during the years for the period from January 1, 2022 to December 31, 2025 according to Notice of Taxation on Continuing the Preferential Policies for Enterprise Income Tax in Qianhai Shenzhen Hong Kong Modern Service Industry Cooperation Zone (《關於延續深圳前海深港現代服務業合作區企業所得稅優惠政策的通知》) issued by the Ministry of Finance (財政部) and the State Taxation Administration (稅務總局). On February 6, 2026, the Qianhai Shenzhen Hong Kong Modern Service Industry Cooperation Zone Administration issued a new notice, extending the implementation period of the mentioned corporate income tax preferential policy until December 31, 2027. Changjiu Jinfu accrued income tax expense based on income tax rate of 15% for the six months ended June 30, 2026 and June 30, 2025.

Under the Law of the PRC on Enterprise Income Tax (《中華人民共和國企業所得稅法》) (the “EIT Law”) and Implementation Regulation of the EIT Law (《中華人民共和國企業所得稅法實施條例》), the enterprise income tax rate of the Group's PRC subsidiaries is 25%, unless subject to tax deduction or exemption. The effective tax rate of 24.6% for the Reporting Period was lower than the 25% statutory tax rate primarily due to the effect of the abovementioned factors (effective tax rate for the six months ended June 30, 2025: 20.1%).

財務開支／收入淨額

於報告期內，本集團錄得財務開支淨額人民幣3.2百萬元，而截至2025年6月30日止六個月則為財務收入淨額人民幣2.9百萬元。此按年變動人民幣6.1百萬元，主要由現金及現金等價物減少導致的本集團利息收入減少以及本集團銀行貸款及其他借款的利息開支增加所帶動。

所得稅開支及實際稅率

所得稅開支由截至2025年6月30日止六個月的人民幣16.9百萬元減少人民幣9.0百萬元或53.3%至報告期的人民幣7.9百萬元。於2023年12月，長久金孚與相關稅務機關確認，根據財政部及稅務總局頒佈的《關於延續深圳前海深港現代服務業合作區企業所得稅優惠政策的通知》，其於2022年1月1日至2025年12月31日期間有權享有15%的所得稅稅率。於2026年2月6日，前海深港現代服務業合作區發佈新通知，延長上述稅收優惠政策的實施期直至2027年12月31日。長久金孚於截至2026年6月30日及2025年6月30日止六個月按15%的所得稅稅率計提所得稅開支。

根據《中華人民共和國企業所得稅法》(「企業所得稅法」)及《中華人民共和國企業所得稅法實施條例》，本集團中國附屬公司的企業所得稅率為25%，惟稅務減免除外。報告期的實際稅率為24.6%，低於25%的法定稅率，主要由於上述因素之影響所致(截至2025年6月30日止六個月之實際稅率：20.1%)。

Profit for Reporting Period and Net Profit Margin

As a result of the foregoing, the net profit decreased by RMB43.0 million or 64.1% from RMB67.1 million for the six months ended June 30, 2025 to RMB24.1 million for the Reporting Period, and the net profit margin decreased from 9.6% for the six months ended June 30, 2025 to 4.9% for the Reporting Period.

Non-IFRS Measure

To supplement its historical financial information which are presented in accordance with IFRS, the Group also uses adjusted net profit as an additional financial measure, which is unaudited in nature and is not required by, or presented in accordance with IFRS. The Group believes that this non-IFRS measure facilitates comparisons of operating performance from year to year by eliminating potential impacts of items that the management does not consider to be indicative of its operating performance. The Group believes that this measure provides useful information to investors and others in understanding and evaluating its results of operations in the same manner as it helps the Group's management. However, the Group's presentation of adjusted net profit may not be comparable to similarly titled measures presented by other companies. The use of this non-IFRS measure has limitations as an analytical tool, and should not be considered in isolation from, or as a substitute for analysis of, the Group's results of operations or financial condition as reported under IFRS.

The Group defines adjusted net profit as net profit adjusted by adding back share-based compensation expenses in relation to share incentive plans and by deducting other income from termination of other payables to customer. The Group eliminates the potential impact of these items, which are either non-operating or one-off in nature and are not indicative of the actual operating performance of the Group.

Adjusted net profit (non-IFRS measure), defined as net profit adjusted by adding back share-based compensation expenses in relation to share incentive plans and by deducting other income from termination of other payables to customer, for the Reporting Period amounted to RMB19.7 million, representing a decrease of 70.8% from RMB67.3 million for the six months ended June 30, 2025.

非國際財務報告準則指標

為補充根據國際財務報告準則呈報的歷史財務資料，本集團亦使用經調整純利作為額外的財務指標，該項指標未經審核，並非國際財務報告準則所要求，亦非根據國際財務報告準則呈報。本集團認為，此項非國際財務報告準則指標通過消除管理層認為不能反映其經營表現的項目的潛在影響，有助比較各年度的經營表現。本集團認為，這一指標能為投資者及其他人士提供有用資料，幫助彼等了解和評估本集團經營業績，正如幫助本集團管理層一般。然而，本集團對經調整純利的呈報可能無法與其他公司呈報的類似指標進行比較。作為一種分析工具，該項非國際財務報告準則指標的使用有其局限性，不應將其與根據國際財務報告準則報告的本集團經營業績或財務狀況分開考慮，亦不應將其替代對有關業績或財務狀況的分析。

Intangible Assets

The Group's intangible assets primarily reflecting the book value of the Group's VFS system, and the North Star System, the Financial Stellar System and the RedSea System. The Group's intangible assets decreased from RMB12.8 million as of December 31, 2025 to RMB12.1 million as of June 30, 2026, primarily due to amortization, partly offset by software acquisition.

Right-of-use assets

The Group's right-of-use assets consisted primarily of leases for offices for the staff. The Group's right-of-use assets increased from RMB7.7 million as of December 31, 2025 to RMB17.7 million as of June 30, 2026, primarily due to a two-year lease renewal for the Group's Beijing office during the Reporting Period, partly offset by an early termination.

Trade Receivables

The Group's trade receivables primarily represent outstanding amounts due from financial institutions, automobile dealerships and related parties.

The Group's trade receivables as of June 30, 2026 amounted to RMB272.9 million, representing an increase of RMB8.9 million or 3.4% as compared to RMB264.0 million as of December 31, 2025, primarily as a result of the growth of the trade receivables of the pledged vehicle monitoring services.

Inventory

The Group's inventories primarily represent the automobiles purchased from FAW Toyota Motor Sales Co., Ltd. that have not yet been sold as of June 30, 2026.

The Group's inventories as of June 30, 2026 amounted to RMB228.9 million, representing a decrease of RMB42.8 million from RMB271.7 million as of December 31, 2025, primarily as a result of a decrease of the automobiles of Corolla 1.2T purchased from FAW Toyota Motor Sales Co., Ltd. that have not yet been sold as of June 30, 2026.

使用權資產

本集團的使用權資產主要包括用作員工辦公室的租賃。本集團的使用權資產由截至2025年12月31日的人民幣7.7百萬元增加至截至2026年6月30日的人民幣17.7百萬元，主要由於報告期內就本集團於北京的辦事處重續兩年的租約，部分被提早終止所抵銷。

貿易應收款項

本集團的貿易應收款項主要指應收金融機構、汽車經銷商及關聯方的未付款項。

截至2026年6月30日，本集團的貿易應收款項為人民幣272.9百萬元，較截至2025年12月31日的人民幣264.0百萬元增加人民幣8.9百萬元或3.4%，主要因質押車輛監控服務的貿易應收款項增加所致。

存貨

本集團的存貨主要指截至2026年6月30日自一汽豐田汽車銷售有限公司購買的尚未出售的汽車。

本集團截至2026年6月30日的存貨為人民幣228.9百萬元，較截至2025年12月31日的人民幣271.7百萬元減少人民幣42.8百萬元，主要由於截至2026年6月30日自一汽豐田汽車銷售有限公司購買的尚未出售的卡羅拉1.2T汽車減少所致。

As of June 30, 2026, the bank loans and other borrowings of the Group was RMB99.9 million, representing a decrease of RMB159.6 million from RMB259.4 million as of December 31, 2025, primarily as a result of repayment of bank loans and other borrowings.

Prepaid Expenses and Other Current Assets

The Group's prepaid expenses and other current assets primarily consist of (i) prepayment for purchase of automobiles; (ii) input valued-added tax recoverable; (iii) prepaid expenses; (iv) amounts due from related parties; and (v) deposits.

The Group's prepaid expenses and other current assets as of June 30, 2026 amounted to RMB134.7 million, representing an increase of RMB61.5 million or 84.0% as compared to RMB73.2 million as of December 31, 2025, primarily due to an increase in the prepayment for purchase of automobiles for the business of the new automobile circulation services.

Trade Payables

The Group's trade payables primarily consist of payments due to the Group's logistics and storage services provider related to the new automobiles circulation services and subcontracting service providers.

The Group's trade payables decreased by RMB13.3 million or 27.3% from RMB48.7 million as of December 31, 2025 to RMB35.4 million as of June 30, 2026. The decrease was due to a decrease in the trade payables of Group's new automobile circulation services.

預付開支及其他流動資產

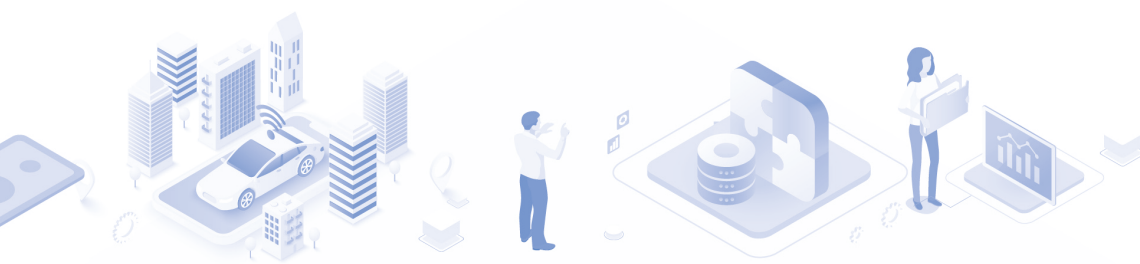
本集團的預付開支及其他流動資產主要包括(i)購買汽車的預付款項；(ii)可收回進項增值稅；(iii)預付開支；(iv)應收關聯方款項；及(v)按金。

截至2026年6月30日，本集團的預付開支及其他流動資產為人民幣134.7百萬元，較截至2025年12月31日的人民幣73.2百萬元增加人民幣61.5百萬元或84.0%，主要因就新汽車流通服務業務購買汽車的預付款項增加所致。

貿易應付款項

本集團的貿易應付款項主要包括應付本集團有關新汽車流通服務的物流及倉儲服務提供方及分包服務提供方款項。

本集團的貿易應付款項由截至2025年12月31日的人民幣48.7百萬元減少人民幣13.3百萬元或27.3%至截至2026年6月30日的人民幣35.4百萬元。該減少乃由於本集團新汽車流通服務的貿易應付款項減少所致。

Liquidity, Financial Resources and Capital Structures

As of June 30, 2026, the Group had cash and cash equivalents of RMB140.0 million.

As of June 30, 2026, the Group had interest-bearing bank loans and other borrowings amounting to RMB99.9 million (December 31, 2025: RMB259.4 million). Interests of the bank loans and other borrowings were charged at fixed rate. The maturity range of the bank loan and other borrowings is within one year. Such bank loan and borrowings were all denominated in RMB. The gearing ratio (total interest-bearing debts divided by total equity) as of June 30, 2026 was 18.7% (December 31, 2025: 50.6%). The current ratio (total current assets divided by total current liabilities) as of June 30, 2026 was 2.8 (December 31, 2025: 2.1).

The Group finances its working capital requirements through a combination of funds generated from operations and alternative funding resources from equity and debt. The Group did not carry out any interest rate hedging policy.

The Shares of the Company were successfully listed on the Main Board of the Stock Exchange on January 9, 2024. There has been no change in the capital structure of the Company since then. The share capital of the Company is only comprised of ordinary shares. As of the date of this report, the issued share capital of the Company was US\$134.7740072, comprising 202,160,000 Shares with a par value of US\$0.00000066667 per Share.

Capital Expenditure and Commitments

The Group's capital expenditure in Reporting Period primarily comprised expenditure on property, plant and equipment and intangible assets, amounting to a total of RMB1.6 million (December 31, 2025: RMB5.0 million).

As of June 30, 2026, the Group had capital commitments of RMB1.6 million associated with the acquisition of certain software for office management (December 31, 2025: RMB13.2 million).

Pledge of Assets

As of June 30, 2026, the Group's trade receivables from financial institutions, with an initial amount of RMB178.1 million, were pledged to secure certain bank loans granted to the Group (December 31, 2025: RMB178.1 million).

流動資金、財務資源及資本結構

截至2026年6月30日，本集團的現金及現金等價物為人民幣140.0百萬元。

截至2026年6月30日，本集團計息銀行貸款及其他借款為人民幣99.9百萬元（2025年12月31日：人民幣259.4百萬元）。銀行貸款及其他借款以固定利率計息。銀行貸款及其他借款於一年內到期。該等銀行貸款及借款均以人民幣計值。截至2026年6月30日，槓桿比率（計息債務總額除以權益總額）為18.7%（2025年12月31日：50.6%）。截至2026年6月30日，流動比率（流動資產總額除以流動負債總額）為2.8（2025年12月31日：2.1）。

本集團通過經營所得資金以及股權和債務等其他資金來源撥付其營運資金需求。本集團概無實施任何利率對沖政策。

本公司股份於2024年1月9日在聯交所主板成功上市。本公司的資本結構自此並無任何變化。本公司的股本僅由普通股組成。截至本報告日期，本公司已發行股本為134.7740072美元，包括202,160,000股每股股份面值0.00000066667美元的股份。

資本開支及承擔

於報告期內，本集團的資本開支主要包括物業、廠房及設備以及無形資產開支，合共人民幣1.6百萬元（2025年12月31日：人民幣5.0百萬元）。

截至2026年6月30日，本集團的資本承擔為人民幣1.6百萬元，與購買若干辦公管理軟件有關（2025年12月31日：人民幣13.2百萬元）。

資產質押

截至2026年6月30日，本集團初始金額為人民幣178.1百萬元之來自金融機構的貿易應收款項已抵押作為本集團獲授若干銀行貸款的擔保（2025年12月31日：人民幣178.1百萬元）。

As of June 30, 2026, a subsidiary of the Group had a pending lawsuit in respect of computer software development contract disputes. If the subsidiary is found to be liable, the total expected monetary compensation may amount to approximately RMB1.7 million. The subsidiary continues to deny any liability in respect of the dispute aforesaid and, based on legal advice, the directors do not believe it probable that the courts will find against them. No provision has therefore been made in respect of the claim.

The Company does not have any material contingent liability.

Material Legal Proceedings

During the Reporting Period and up to the date of this report, save as disclosed herein, the Company was not involved in any material legal proceeding or arbitration. To the best knowledge of the Directors, as at the date of this report, save as disclosed herein, there is no material legal proceeding or claim which is pending or threatened against the Company.

During the Reporting Period, a commercial bank filed two civil lawsuits against a subsidiary of the Group, alleging that it failed to fulfill its contractual obligations to monitor the pledged vehicles in accordance with the Tripartite Pledge Vehicle Monitoring Service Agreement, resulting in the automobile dealer's unauthorized sale of the pledged vehicles and causing the bank to lose its priority right to repayment under the pledge. On August 10, 2026, the court of first instance ruled that the subsidiary was liable due to supervisory deficiencies and ordered it to pay the commercial bank a total of RMB38.4 million in compensation. The subsidiary has appealed the judgments. The Group believes that even if the judgments are upheld, it will not have a material adverse effect on the Group's daily operations or overall debt-repayment capacity. As of the date of this report, the Company has recognized a provision of RMB38.6 million as of June 30, 2026 in connection with the aforementioned case, which includes a case filing fee of RMB0.2 million. The Group will closely monitor the case and will disclose any significant developments.

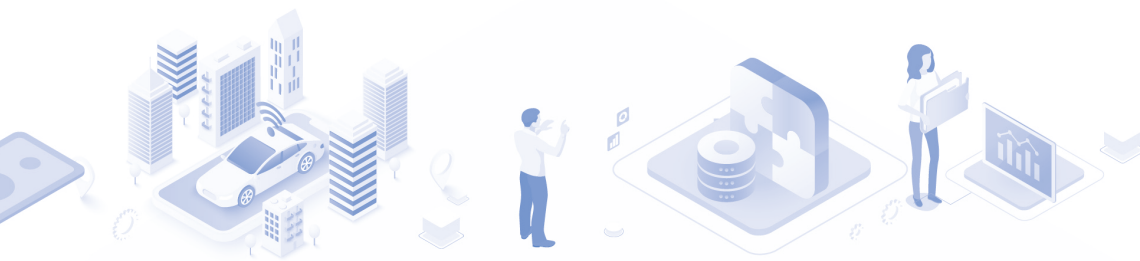

重大法律訴訟

於報告期內及直至本報告日期，除本報告所披露者外，本公司概無涉及任何重大法律訴訟或仲裁。據董事所深知，於本報告日期，除本報告所披露者外，本公司概無尚未了結或面臨威脅的重大法律訴訟或索賠。

於報告期內，一家商業銀行對本集團一間附屬公司提起兩宗民事訴訟，聲稱其未能履行其合約義務，以根據三方質押車輛監控服務協議監控質押車輛，導致汽車經銷商擅自出售質押車輛，致使該銀行喪失質權優先受償權。於2026年8月10日，一審法院裁定該附屬公司因監管瑕疵須承擔責任，並裁定其須向該商業銀行支付共計人民幣38.4百萬元的賠償金，附屬公司已就判決結果進行上訴。本集團認為，如維持該判決，亦不會對本集團的日常營運或整體償債能力產生重大不利影響。截至本報告日期，本公司已針對上述案件確認截至2026年6月30日的計提金額為人民幣38.6百萬元，其中包括案件受理費人民幣0.2百萬元。本集團將密切跟進案件，出現重大進展將對外披露。

Cash Flow

For the Reporting Period, the net cash used in operating activities was RMB10.9 million, which was primarily income tax paid, partly offset by net cash generated from operations. The net cash generated from investing activities for the Reporting Period was RMB0.4 million, which was net receipt from related parties, partly offset by purchase of property, plant and equipment and acquisition of intangible assets. The net cash used in financing activities for the Reporting Period was RMB169.4 million, which was primarily due to the repayment of bank loans and other borrowings.

Foreign Exchange Risk

The Group operates its business primarily in the PRC. RMB is the major currency used by the Group for valuation and settlement of all transactions. Any depreciation of RMB would adversely affect the value of any dividends paid by the Group to shareholders outside the PRC. As of June 30, 2026, except for cash and cash equivalents denominated in foreign currencies, the Group did not have significant foreign currency exposure from its operations. Majority of the Group's cash and cash equivalents is denominated in RMB and HKD. The Group is currently not engaged in hedging activities that are designed or intended to manage foreign exchange rate risk. The Group will continue to monitor foreign exchange activities and make its best efforts to protect the cash value of the Group.

Treasury Policy

The Group has adopted a prudent financial management approach towards its treasury policy and thus maintained a healthy liquidity position for the Reporting Period. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

During the Reporting Period, the Group did not have any material acquisitions or disposals of subsidiaries, associates and joint ventures. As of June 30, 2026, the Group did not hold any significant investments (including significant investments which accounted for 5% or more of the total assets of the Group).

現金流量

於報告期內，經營活動所用現金淨額為人民幣10.9百萬元，主要為已付所得稅，部分被經營活動所得現金淨額所抵銷。於報告期內，投資活動所得現金淨額為人民幣0.4百萬元，主要為向關聯方收款淨額，部分被購買物業、廠房及設備以及收購無形資產所抵銷。報告期內，融資活動所用現金淨額為人民幣169.4百萬元，主要由於償還銀行貸款及其他借款所致。

外匯風險

本集團主要在中國經營業務。人民幣為本集團用於所有交易估值及結算的主要貨幣。人民幣的任何貶值均會對本集團支付予中國境外股東的任何股息價值產生不利影響。截至2026年6月30日，除以外幣計值的現金及現金等價物外，本集團的運營並無重大外幣風險。本集團現金及現金等價物絕大部分以人民幣及港元計值。本集團目前並無參與旨在或擬管理外匯匯率風險的對沖活動。本集團將繼續監控外匯活動，並盡最大努力保護本集團現金價值。

庫務政策

本集團就其庫務政策採取審慎的財務管理方法，因此得以於報告期內維持穩健的流動資金狀況。為管理流動資金風險，董事會密切監控本集團的流動資金狀況，確保本集團的資產、負債和其他承擔的流動資金結構能滿足其不時的資金需求。

有關附屬公司、聯營公司及合營企業的重大投資、重大收購及出售

於報告期內，本集團概無任何涉及附屬公司、聯營公司及合營企業的重大收購或出售。截至2026年6月30日，本集團並未持有任何重大投資（包括佔本集團資產總值5%或以上的重大投資）。



EMPLOYEES AND REMUNERATION POLICY

The Group employed 521 employees as of June 30, 2026 (December 31, 2025: 633; as of June 30, 2025: 641). For the six months ended June 30, 2026, the staff cost of the Group (including Directors' remuneration) amounted to approximately RMB68.1 million (the six months ended June 30, 2025: RMB64.6 million). To promote employees' knowledge and technical expertise, the Group offers training programmes to employees from time to time according to their job duties. Employees' remuneration packages are determined with reference to the market information and individual performance and will be reviewed on a regular basis. The remuneration policy will be reviewed by the Board from time to time. In addition to basic remuneration, the Group also makes contributions to mandatory social security funds for the benefit of the PRC employees that provide for retirement insurance, medical insurance, unemployment insurance, maternity insurance, occupational injury insurance and housing funds. All of the full-time employees are paid a fixed salary and may be granted other allowances, based on their positions. Those who meet or exceed their performance expectation will also be rewarded discretionary bonuses. Selected Director, senior management members and employees were offered to participate in the pre-IPO restricted share plan (the "Pre-IPO Restricted Share Plan") and the pre-IPO share option plan (the "Pre-IPO Share Option Plan"), both approved and adopted by the Company on March 7, 2023.

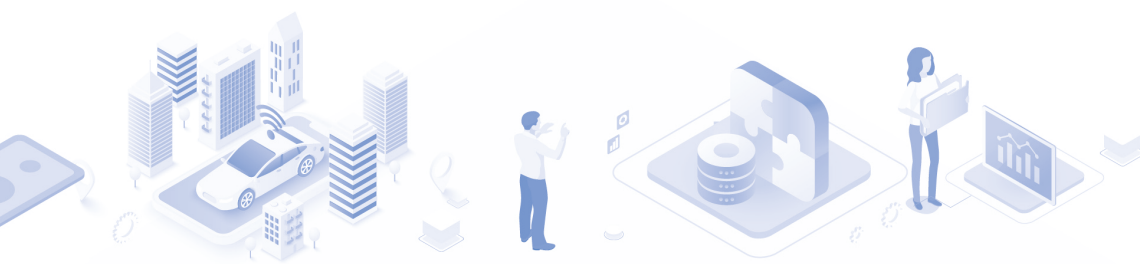
The Shares of the Company were listed on the Main Board of the Stock Exchange on January 9, 2024. The Company issued 50,540,000 ordinary Shares at an offer price of HK\$5.95 per share, raising net proceeds of HK\$254.1 million (after deducting the Listing expenses) under the Global Offering.

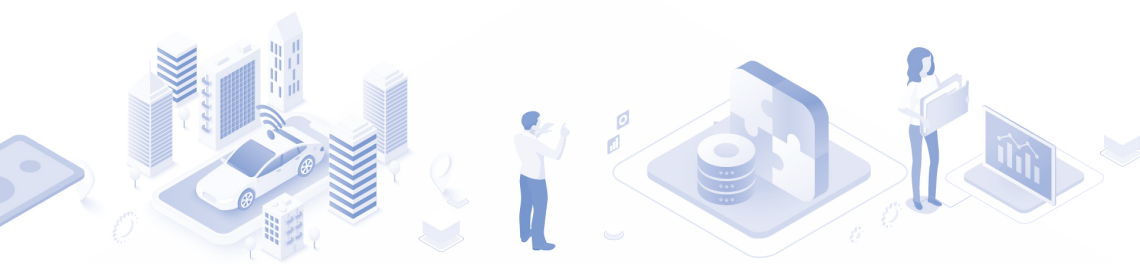

The Audit Committee has also reviewed the accounting principles and practices adopted by the Group.

1 Principal activities and organization

Changjiu Holdings Limited (the “**Company**”), formerly known as Changjiu Digital Technology Limited, was incorporated in the Cayman Islands on June 16, 2021 as an exempted company with limited liability under the Companies Act (Revised) of the Cayman Islands. On September 19, 2023, the Company changed its name from Changjiu Digital Technology Limited to Changjiu Holdings Limited.

The Company is an investment holding company. The Company and its subsidiaries (together as the “**Group**”) are principally engaged in the provision of pledged vehicle monitoring services, automobile dealership operation management services and new automobile circulation services (“**the Businesses**”) across Mainland China.

The Company’s shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on January 9, 2024.

2 Basis of preparation

This interim financial report has been prepared in accordance with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, including compliance with International Accounting Standard (“**IAS**”) 34, *Interim financial reporting*, issued by the International Accounting Standards Board (“**IASB**”). It was authorised for issue on August 27, 2026.

The interim financial report has been prepared in accordance with the same accounting policies adopted in the 2025 annual financial statements, except for the accounting policy changes that are expected to be reflected in the 2026 annual financial statements. Details of any changes in accounting policies are set out in Note 3.

The preparation of an interim financial report in conformity with IAS 34 requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a year to date basis. Actual results may differ from these estimates.

本公司股份於2024年1月9日在香港聯合交易所有限公司(「**聯交所**」)主板上市。

2 編製基準

本中期財務報告乃根據香港聯合交易所有限公司證券上市規則的適用披露條文(包括遵守國際會計準則理事會(「**國際會計準則理事會**」)頒佈的國際會計準則(「**國際會計準則**」)第34號中期財務報告)編製。其於2026年8月27日獲授權刊發。

除預期將於2026年年度財務報表中反映的會計政策變動，中期財務報告乃根據2025年年度財務報表所採納的相同會計政策編製。任何會計政策變動之詳情載於附註3。

The notes include an explanation of events and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the 2025 annual financial statements. The condensed consolidated interim financial statements and notes thereon do not include all of the information required for a full set of financial statements prepared in accordance with IFRS Accounting Standards.

The interim financial report is unaudited, but has been reviewed by KPMG in accordance with Hong Kong Standard on Review Engagements 2410, *Review of interim financial information performed by the independent auditor of the entity*, issued by the HKICPA. KPMG's independent review report to the Board of Directors is included on page 44 to 45.

3 Changes in accounting policies

The Group has applied the following new and amended IFRS Accounting Standards issued by the IASB to these interim financial statements for the current accounting period.

- Amendments to IFRS 9 and IFRS 7, *Classification and Measurement of Financial Instruments*
- Annual Improvements to IFRS Accounting Standards – Volume 11

None of the developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented in the interim financial report. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

The Company was incorporated in the Cayman Islands in June 2021 with an authorized share capital of USD50,000 divided into 50,000 shares with a par value of USD1.0 each. Upon incorporation, the Company issued 100 ordinary shares.

On February 15, 2023, the Company's issued and unissued 50,000 shares of a par value of USD1.0 each were subdivided into 75,000,000,000 shares with a par value of USD0.00000066667 each. As a result, the issued share capital of the Company became 150,000,000 shares of USD0.00000066667 par value each.

On March 7, 2023, the Company adopted the Pre-IPO Restricted Share Plan and granted a total number of 1,620,000 restricted shares with a par value of USD0.00000066667 each to one director and certain employees. As of December 31, 2023, the Company had received the capital contributions.

Upon completion of the Initial Public Offering, the Company issued 50,540,000 new ordinary shares with a par value of USD0.00000066667 each for offering price of HKD5.95 each. The respective share capital amount was approximately RMB239.26 and share premium arising from the issuance was approximately RMB260.1 million, net of the share issuance costs.
