The board (the “**Board**”) of directors (the “**Director(s)**”) of Chinese People Holdings Company Limited (the “**Company**”) is hereby to announce the unaudited condensed consolidated financial statements of the Company and its subsidiaries (collectively the “**Group**”) for the six months ended 30 June 2026 (the “**Period**” or “**Reporting Period**”).

BUSINESS REVIEW

In the first half of 2026, China’s energy is supplied in a stable and orderly manner, with oil and gas output reaching a record high for the same period. China’s natural gas industry is well positioned for promising development prospect.

In the first half of 2026, the consumption of domestic natural gas was approximately 435.0 billion m³, representing a year-on-year decrease of approximately 1.00%; the natural gas production was approximately 133.0 billion m³, representing a year-on-year increase of approximately 1.60%; the imported natural gas was approximately 573.8 billion m³, representing a year-on-year decrease of approximately 3.5%, of which the piped gas was approximately 40.6 billion m³, and liquefied natural gas was approximately 39.7 billion m³.

As of the Reporting Period, the revenue of the Group amounted to approximately RMB1,140 million (2025: RMB1,228 million), representing a decrease of approximately 7.17% as compared with the corresponding period of last year, while profit of the Group for the Period was approximately RMB67.02 million (2025: RMB77.50 million), representing a decrease of approximately 13.52% as compared with the corresponding period of last year. Basic earnings per share of the Company was RMB0.58 cents (2025: RMB0.72 cents). The gross profit margin of the Group was approximately 11.75% (2025: 12.17%), representing a decrease of approximately 0.42 points as compared with the corresponding period of last year. The gross profit margin was largely in line with the corresponding period of last year.

中民控股有限公司(「本公司」)董事(「董事」)會(「董事會」)僅此公佈，本公司及其附屬公司(統稱「本集團」)截至2026年6月30日止六個月(「本期間」或「本報告期間」)未經審核簡明綜合財務報表。

業務回顧

2026年上半年，中國能源供應平穩有序，油氣產量創歷史同期新高，中國天然氣產業具備良好發展前景。

2026年上半年，全國天然氣消費量約4,350億立方米，同比下降約1.00%；天然氣產量約1,330億立方米，同比增長約1.60%；天然氣進口量約5,738億立方米，同比減少約3.5%，其中管道氣約406億立方米，液化天然氣約397億立方米。

截至本報告期間，本集團收入約人民幣11.40億元(2025年：人民幣12.28億元)，較去年同期減少約7.17%，本期間本集團溢利約人民幣67.02百萬元(2025年：人民幣77.50百萬元)，較去年同期減少約13.52%。本公司每股基本盈利為人民幣0.58分(2025年：人民幣0.72分)。本集團的毛利率約11.75%(2025年：12.17%)，較去年同期減少約0.42點。毛利率基本與去年同期持平。

Piped Gas Transmission and Distribution Business

Piped gas transmission and distribution business is one of our main businesses and major source of income of the Group. For the Period, revenue of approximately RMB556,723,000 was recorded from our piped gas transmission and distribution business, representing a decrease of approximately RMB26,227,000 or 4.50% as compared with the corresponding period of last year, which accounted for approximately 48.83% (2025: 47.47%) of our total revenue. The gross profit margin of piped gas transmission and distribution business for the Period was approximately 11.41% (2025: 11.95%). The decrease in gross profit margin of piped gas transmission and distribution business was mainly due to the decrease in the gross profit margin of piped gas connection.

— Piped Gas Connection

During the Period, revenue from piped gas connection was approximately RMB24,114,000, representing a decrease of approximately RMB4,359,000 or 15.31% as compared with the corresponding period of last year, which represented approximately 4.33% (2025: 4.88%) of the total revenue of the piped gas transmission and distribution business. During the Period, there was an addition of 6,053 units of connected residential household customers and 223 units of connected commercial and industrial (“C/I”) customers, respectively. As of 30 June 2026, the accumulated number of connected residential household customers was 611,325 units; and the accumulated number of connected C/I customers was 13,998 units, representing an increase of approximately 2.68% and 3.97%, respectively as compared with the corresponding period of last year.

管道燃氣輸配業務

管道燃氣輸配業務作為我們的主要業務之一，為本集團的主要收入來源。截至本期間，我們的管道燃氣輸配業務實現收入約人民幣556,723,000元，較去年同期減少約人民幣26,227,000元或4.50%，管道燃氣輸配業務收入佔我們總收入約48.83%（2025年：47.47%）。本期間管道燃氣輸配業務的毛利率約11.41%（2025年：11.95%）。管道燃氣輸配業務的毛利率下降主要由於管道燃氣接駁毛利率下降所致。

— 管道燃氣接駁

於本期間，管道燃氣接駁費收入約人民幣24,114,000元，較去年同期減少約人民幣4,359,000元或15.31%，管道燃氣接駁費收入佔管道燃氣輸配業務總收入約4.33%（2025：4.88%）。於本期間，新增接駁居民用戶6,053戶，新增接駁工商業用戶223戶。截至2026年6月30日，累計已接駁居民用戶611,325戶，累計已接駁工商業用戶13,998戶，分別較去年同期增加約2.68%及3.97%。

Piped Gas Transmission and Distribution Business (Continued)

– Piped Gas Sales

During the Period, revenue from piped gas sales was approximately RMB532,609,000, representing a decrease of approximately RMB21,868,000 or 3.94% as compared with the corresponding period of last year. The decrease in revenue was mainly due to the decrease in sales volume to C/I customers. Revenue from piped gas sales accounted for approximately 95.67% (2025: 95.12%) of the total revenue from the piped gas transmission and distribution business. Our piped gas sales achieved approximately 210.70 million m³ (2025: 213.56 million m³), representing a decrease of approximately 1.34% as compared to the corresponding period of last year. Among the total sales, approximately 85.56 million m³ (2025: 81.67 million m³) were sold to residential household customers, which represented an increase of approximately 4.76% as compared with the corresponding period of last year; approximately 125.14 million m³ (2025: 131.89 million m³) were sold to C/I customers, which represented a decrease of approximately 5.12% as compared with the corresponding period of last year.

Cylinder Gas Supply Business

Cylinder gas business is another major businesses of the Group. Currently, the Group's cylinder gas business is mainly the sales of liquefied natural gas (LNG), liquefied petroleum gas (LPG), and liquefied dimethyl ether (DME) with cylinder. During the Period, while maintaining existing customers, we actively develop new customers for expanding the sales markets.

管道燃氣輸配業務 (續)

– 管道燃氣銷售

於本期間，管道燃氣銷售收入約人民幣532,609,000元，較去年同期減少約人民幣21,868,000元或3.94%。收入下降主要由於工商業用戶銷售量降低。管道燃氣銷售收入佔管道燃氣輸配業務總收入約95.67% (2025年：95.12%)。共實現管道燃氣銷售量約21,070萬立方米 (2025年：21,356萬立方米)，較去年同期減少約1.34%。其中，向居民用戶銷售管道燃氣約8,556萬立方米 (2025年：8,167萬立方米)，較去年同期增約4.76%；向工商業用戶銷售管道燃氣約12,514萬立方米 (2025年：13,189萬立方米)，較去年同期減少約5.12%。

罐裝燃氣供應業務

罐裝燃氣業務為本集團的另一項主要業務。目前本集團的罐裝燃氣業務主要為液化天然氣 (LNG)、液化石油氣 (LPG) 和二甲醚 (DME) 的罐裝銷售。於本期間，我們在維護固有客戶的同時，積極開發新用戶，擴大銷售市場。

Cylinder Gas Supply Business (Continued)

During the Period, sales of cylinder gas was approximately 42,263 tons (2025: 48,054 tons) in total, representing a decrease of approximately 12.05% over the corresponding period of last year. A total sales revenue reached approximately RMB261,443,000 (2025: RMB270,033,000), representing a decrease of approximately RMB8,590,000 or 3.18% over the corresponding period of last year. The gross profit margin of cylinder gas supply business during the Period was approximately 26.01% (2025: 28.01%). During the Period, revenue from cylinder gas supply business accounted for approximately 22.93% (2025: 21.99%) of the total revenue of the Group. The decrease in gross profit margin was due to the proportional increase in the purchase and sales prices of gas, with the unit gross profit margin remaining basically unchanged.

Gas Distribution Business

Gas distribution business represents a business carried out by the Group in recent years, which has recently formed a certain business scale. The gas distribution business mainly purchases a large amount of gas resources from upstream suppliers and then distributes to other gas operating companies. Although investment in this business is not large, it can form a dominant position in the market at a lower cost, which is helpful for the development of downstream terminal business of the Group.

During the Period, revenue from gas distribution business was approximately RMB320,173,000, representing a decrease of approximately RMB53,604,000 or 14.34% as compared with the corresponding period of last year. The sales of gas was approximately 76,514 tons (2025: 99,334 tons), representing a decrease of approximately 22.97% as compared with the corresponding period of last year. During the Period, revenue from gas distribution business accounted for approximately 28.08% (2025: 30.44%) of the Group's total revenue. The gross profit margin of gas distribution business during the Period was approximately 0.43% (2025: 0.78%). The decrease in gross profit margin was mainly due to less increase in selling price than that in purchase price.

罐裝燃氣供應業務 (續)

於本期間，共銷售罐裝燃氣約42,263噸（2025年：48,054噸），較去年同期減少約12.05%。共實現銷售收入約人民幣261,443,000元（2025年：人民幣270,033,000元），較去年同期減少約人民幣8,590,000元或3.18%。於本期間罐裝燃氣供應業務的毛利率約為26.01%（2025年：28.01%）。於本期間，罐裝燃氣供應業務收入佔本集團總收入之約22.93%（2025年：21.99%）。毛利率下降主要因為燃氣購銷價格同比上漲，而單位毛利基本保持不變所致。

燃氣分銷業務

燃氣分銷業務為本集團近年開展的一項業務，目前已經形成一定的業務規模。燃氣分銷業務主要是從上游供應商大量採購燃氣資源，分銷給其他的燃氣經營企業，該項業務投資不大，但能夠在市場上以較低的成本形成市場優勢地位，對本集團下游終端業務的開展也具有一定的幫助作用。

於本期間，燃氣分銷業務收入約人民幣320,173,000元，較去年同期減少約人民幣53,604,000元或14.34%。共銷售燃氣約76,514噸（2025年：99,334噸），較去年同期減少約22.97%。於本期間燃氣分銷業務收入佔本集團總收入約28.08%（2025年：30.44%）。於本期間燃氣分銷業務的毛利率約0.43%（2025年：0.78%）。毛利率下降主要因為銷售價上漲幅度小於採購價上漲幅度。

Other Business

The food ingredients supply and the fast-moving consumer goods ("FMCG") business was considered as other business of the Group due to the business is managed and operated by the third parties and the Group is being paid usage fee on a regularly basis.

During the Period, the other business realised revenue of approximately RMB1,765,000 (2025: RMB1,329,000), accounting for approximately 0.16% (2025: 0.10%) of the Group's total revenue. A profit of approximately RMB287,000 was recorded (a loss of approximately RMB622,000 in 2025) for the Period.

New Project During the Period

There was no new significant project for the Period.

Other Gains and Losses

Other gains and losses for the Reporting Period amounted to losses of approximately RMB233,000 (2025: losses of RMB6,307,000), representing a decrease in losses of approximately RMB6,074,000 as compared to the corresponding period of last year. Such decrease was mainly due to decreases in foreign exchange loss and net of reversal of impairment losses.

Other Income

Other income for the Reporting Period amounted to approximately RMB20,303,000 (2025: RMB15,157,000), representing an increase of approximately RMB5,146,000 as compared with the corresponding period of last year. Such increase was mainly due to the increase in bank interest income and sales of materials income.

Finance Costs

Finance costs for the Reporting Period amounted to approximately RMB874,000 (2025: RMB1,620,000), representing a decrease of approximately RMB746,000 as compared to the corresponding period of last year. Such decrease was mainly due to a reduction in interest on bank borrowings.

其他業務

食材供應及賣場業務被視為本集團的其他業務，原因在於該等業務由第三方管理及經營，而本集團定期收取使用費。

於本期間，其他業務實現收入約人民幣1,765,000元（2025年：人民幣1,329,000元），佔本集團總收入約0.16%（2025年：0.10%），本期間實現盈利約人民幣287,000元（2025年虧損約人民幣622,000元）。

於本期間新增項目

於本期間沒有重大新增業務。

其他收益及虧損

本報告期間的其他收益及虧損為虧損約人民幣233,000元（2025年：虧損人民幣6,307,000元），較去年同期虧損減少約人民幣6,074,000元。該減少乃主要由於匯兌損失及信用減值損失減少。

其他收入

本報告期間的其他收入約人民幣20,303,000元（2025年：人民幣15,157,000元），較去年同期增加約人民幣5,146,000元。該增加主要由於銀行利息收入及材料收入增加所致。

財務成本

本報告期間的財務成本約人民幣874,000元（2025年：人民幣1,620,000元），較去年同期減少約人民幣746,000元。該減少乃主要由於銀行借款利息減少所致。

Selling and Distribution Expenses

Selling and distribution expenses for the Reporting Period amounted to approximately RMB61,250,000 (2025: RMB67,100,000), representing a decrease of approximately RMB5,850,000 as compared with the corresponding period of last year, which was mainly due to the decrease in wages and transportation costs, etc.

Administrative Expenses

Administrative expenses for the Reporting Period amounted to approximately RMB54,017,000 (2025: RMB52,755,000), representing an increase of approximately RMB1,262,000 as compared with the corresponding period of last year, which mainly due to increase in wages.

Share of Results of Associates

Share of profit of associates for the Reporting Period amounted to approximately RMB6,626,000 (2025: RMB16,950,000), representing a decrease of approximately RMB10,324,000 as compared to the corresponding period of last year. Such decrease was mainly attributable to the decrease in profit generated by the Company's associates for the Period.

Share of Results of Joint Ventures

Share of profit of joint ventures for the Reporting Period amounted to approximately RMB29,779,000 (2025: RMB34,395,000), representing a decrease of approximately RMB4,616,000 as compared to the corresponding period of last year. Such decrease was mainly attributable to the decrease in profit generated by the Company's joint ventures for the Period.

Income Tax Expenses

Income tax expenses for the Reporting Period amounted to approximately RMB7,235,000 (2025: RMB10,689,000), representing a decrease of approximately RMB3,454,000 as compared to the corresponding period of last year. Such decrease was mainly attributable to the decrease in current tax expenses.

銷售及分銷開支

本報告期間的銷售及分銷開支約人民幣61,250,000元(2025年:人民幣67,100,000元),較去年同期減少約人民幣5,850,000元,主要由於工資及車輛運輸費等減少。

行政開支

本報告期間的行政開支約人民幣54,017,000元(2025年:人民幣52,755,000元),較去年同期增加約人民幣1,262,000元,主要由於工資增加。

應佔聯營公司業績

本報告期間的應佔聯營公司溢利約人民幣6,626,000元(2025年:人民幣16,950,000元),較去年同期減少約人民幣10,324,000元。該減少乃主要由於本期間本公司聯營公司產生的溢利減少所致。

應佔合資企業業績

本報告期間的應佔合資企業溢利約人民幣29,779,000元(2025年:人民幣34,395,000元),較去年同期減少約人民幣4,616,000元。該減少乃主要由於本期間本公司合資企業產生的溢利減少所致。

所得稅開支

本報告期間的所得稅開支約人民幣7,235,000元(2025年:人民幣10,689,000元),較去年同期減少約人民幣3,454,000元。該減少乃主要由於所得稅費用減少所致。

Liquidity and Capital Resources

As at 30 June 2026, the unaudited condensed consolidated financial position of the Group was as follows:

Currently, the sources of the operating and capital expenditure of the Group are operating cash flow, internal current capital and bank borrowings. The Group has sufficient funds to meet future capital expenditures and operational needs.

Borrowing Structure

As at 30 June 2026, the total borrowings of the Group were approximately RMB67,410,000 (31 December 2025: RMB56,960,000), which comprised domestic bank borrowings denominated in RMB of the project companies in China. Borrowings, calculated at Loan Prime Rate announced by the People's Bank of China plus certain basis points of which interest rates are in the range of People's Bank of China base rate plus 0.05% to plus 0.60% (31 December 2025: minus 0.10% to plus 1.00%) per annum, are mainly applied to gas pipelines construction, as general working capital and for operating expenses. Apart from the borrowings of approximately RMB32,650,000 (31 December 2025: RMB28,460,000) which were secured by certain assets with carrying amount of approximately RMB127,228,000 (31 December 2025: RMB131,613,000), others were unsecured. Short-term borrowings amounted to approximately RMB34,760,000 (31 December 2025: RMB24,860,000).

Capital Structure

The long-term capital of the Group comprised equity attributable to owners and borrowings, which was confirmed by the sound debt-to-capitalisation ratio.

Foreign Exchange Risk

As all of our operations are in China and substantially all of its revenue and expenses are denominated in RMB, there was no significant foreign exchange risk in its operation. We currently do not have foreign currency hedging policy but monitor the market trends of exchange rates closely, and adopt appropriate measures when necessary.

流動資金及資本來源

於2026年6月30日，本集團的未經審核簡明綜合財務狀況如下：

現時，本集團的營運及資本性支出的資金來源為營運現金流、內部流動資金及銀行借貸。本集團有足夠的財務資源以應付未來的資本性支出及營運需求。

借貸結構

於2026年6月30日，本集團的借貸總額約人民幣67,410,000元（2025年12月31日：人民幣56,960,000元），主要為項目公司在國內當地銀行人民幣貸款。貸款以中國人民銀行公佈的貸款基礎利率加若干基點計算，其中年息率介乎中國人民銀行基本利率加0.05%至加0.60%（2025年12月31日：減0.10%至加1.00%），作為管道燃氣建設、日常流動資金及營運開支。除了相等於約人民幣32,650,000元（2025年12月31日：人民幣28,460,000元）的貸款需要用賬面值相等於約人民幣127,228,000元（2025年12月31日：人民幣131,613,000元）的部份資產作抵押外，其餘貸款均為無抵押的貸款。短期貸款相等於約人民幣34,760,000元（2025年12月31日：人民幣24,860,000元）。

資本結構

本集團長期資本包括擁有人應佔權益和負債，已透過健康的負債與資本比率獲得確認。

外匯風險

我們的業務均在中國，絕大部份收入與支出以人民幣為主，所以在營運上並無面對重大外匯波動風險，現時我們並無外幣對沖政策，然而，本集團會對市場的匯率走勢緊密地進行監控，在有需要時做出適當調整。

Capital and Other Commitments

As at 30 June 2026, the capital commitments of the Group amounted to approximately RMB16,334,000 (31 December 2025: RMB32,194,000), mainly attributable to running district gas pipelines construction. Details are set out in note 20 to the unaudited condensed consolidated financial statements.

Contingent Liabilities

As at 30 June 2026, the Group has no significant contingent liability.

Event After the End of the Reporting Period

There was no significant event took place subsequent to the end of the reporting date.

Employees

As at 30 June 2026, we had approximately 4,700 employees, most of them were stationed in China. The employees' salaries are determined from time to time with reference to their duties and responsibilities, business performance of the Group and profitability and market conditions. In addition to pension funds, individual employees may be granted discretionary bonus and/or share options as rewards for their performance.

PROSPECTS AND OUTLOOK

The energy mix in the PRC is shifting towards low-carbon and environmentally friendly focus, with natural gas playing an increasingly prominent role. Natural gas is an important cornerstone for the high-quality social and economic development in the PRC, and it shoulders the mission of ensuring energy security and promoting green and low-carbon transformation. Currently, the natural gas consumption structure in the PRC has covered multiple fields such as urban gas, industrial fuel, chemical industry, transportation and power generation, among which urban gas consumption accounts for an overwhelming proportion. During the “15th Five-Year Plan” period, China will vigorously promote oil and gas exploration and development, fully establish “a nationwide network” and develop a unified national natural gas market. Natural gas and LPG remain the major commodities of the Group’s gas business in the future. Natural gas and LPG, as clean and low-carbon fossil energy, will further contribute to the achievement of peak carbon dioxide emissions and carbon neutrality goals in the future. The government will proactively promote the gas industry to achieve high quality development.

Piped Gas Transmission and Distribution Business

In the first half of 2026, urban gas consumption maintained steady growth, and China’s natural gas market generally operated in a stable manner. On the supply side, efforts continued to be made to increase domestic natural gas reserves and production capacity, while maintaining stable supply of imported pipeline gas. Meanwhile, China is advancing the renovation and intelligent upgrading of urban gas pipelines, to further improve energy infrastructure. As the urban gas pipeline renovation and intelligent upgrades advance, China’s urban gas infrastructure will continue to improve. Therefore, we maintain confidence in the future piped gas market. The Group will continue to ensure the safe and effective operation of facilities and provide strong gas guarantee for people’s livelihood.

前景展望

中國的能源結構正在向低碳、環保方向轉變，其中天然氣的角色日益凸顯。天然氣是我國社會經濟高質量發展的重要基石，肩負保障能源安全、推動綠色低碳轉型的使命。目前，中國的天然氣消費結構已經涵蓋了城市燃氣、工業燃料、化工、交通和發電等多個領域，其中城市燃氣的消費佔比最高。「十五五」期間，中國將大力推進油氣勘探開發，全面建成「全國一張網」，構建全國天然氣統一大市場。本集團所經營的燃氣業務中，天然氣和液化石油氣在未來仍將是主要的商品。天然氣和液化石油氣作為清潔低碳的化石能源，未來仍助力碳達峰、碳中和目標的實現，政府將積極推動燃氣產業實現高質量發展。

管道燃氣輸配業務

2026年上半年，城市燃氣用氣穩定增長。中國天然氣市場運行總體平穩。供給持續加大國產氣增儲上產，穩定進口管道氣供應。同時，我國正推進城鎮燃氣管道更新改造及智能化升級工作，不斷完善能源基礎設施建設，隨著城鎮燃氣管道更新改造及智能化升級工作的深入開展，我國城市燃氣基礎設施將不斷完善。因此我們對管道燃氣未來市場保持信心，本集團將持續確保設施運行安全有效，民生用氣保障有力。

PROSPECTS AND OUTLOOK (Continued)

Cylinder Gas Supply Business

The current energy market is at a critical stage of deepening reform. LPG, with its clean, efficient and flexible characteristics, effectively complements the Group's piped gas business. In line with the national strategy of high-quality development, China is accelerating the construction of a clean, low-carbon, safe and efficient new energy system, while coordinating the development of traditional and new energy sources, promoting the clean utilisation of fossil fuels and leveraging their regulatory and supporting role to build a diversified and resilient supply system. The Group is adapting to market changes by continuously optimising its sales strategies and service processes, expanding customer coverage, and striving to meet demand effectively.

The Group, in light of the characteristics of the cylinder gas industry and the actual business needs, will continue to develop and improve CVG gas management systems, to realise digital and information management of cylinder gas business, to promote electronic filling, distribution, information technology for reducing the operating costs and improving distribution efficiency, and to improve the safety and security capabilities of the cylinder gas business. Leveraging favorable policies and development environment and prospect, the Group will strive to ensure safe operation and efficient transportation, so as to expand the market share of areas with no established presences, and create better economic performance.

Gas Distribution Business

In the first half of 2026, China's total energy consumption increased by 2.7% year-on-year, with the growth rate moderating compared to the first quarter. As the pace of green and low-carbon transition accelerates, the proportion of clean energy consumption continues to rise. However, the green transition is not an overnight task; fossil fuels, including natural gas, will continue to play a vital role in providing underpinning security and regulatory support. The Fourth Plenary Session of the 20th CPC Central Committee listed "Achieving New and Significant Progress in Building a Beautiful China" as a key objective for the 15th Five-Year Plan period and dedicated a chapter to its deployment. The "15th Five-Year Plan for Building a Beautiful China" was officially issued in June 2026, charting the direction for high-quality development in the energy sector.

前景展望 (續)

罐裝燃氣供應業務

當前能源市場正處於深化改革關鍵期，罐裝燃氣憑藉清潔、高效與靈活特性，與本集團管道燃氣業務形成有效互補。國家立足高質量發展，加速構建清潔低碳、安全高效的新型能源體系，同時兼顧傳統與新能源協調，促進化石能源清潔利用，發揮其調節支撐作用，以打造多元韌性供給系統。本集團順應市場變化，持續優化銷售策略與服務流程，擴大客戶覆蓋，務求切實滿足需求。

本集團將結合罐裝燃氣行業特點及實際業務需要，持續開發和完善CVG燃氣管理系統，實現罐裝燃氣業務的數字化、信息化管理，推動充裝、配送流程電子化、信息化，以降低運營成本、提升配送效率，同時增強罐裝燃氣業務的安全保障能力。結合政策紅利及行業發展環境與前景，本集團將著力保障安全運行與高效運營，拓展市場空白區域的佔有率，創造更佳的經濟效益。

燃氣分銷業務

2026年上半年，我國能源消費總量同比增長2.7%，增速較一季度有所放緩。隨著綠色低碳轉型步伐加快，清潔能源消費比重持續提高，但綠色轉型非一日之功，包括天然氣在內的化石能源仍將發揮重要的兜底保障與支撐調節作用。黨的二十屆四中全會將「美麗中國建設取得新的重大進展」列為「十五五」時期主要目標並專章部署，《美麗中國建設「十五五」規劃》也已於2026年6月正式印發，為能源行業高質量發展指明了方向。

Gas Distribution Business (Continued)

The Group is seizing opportunities in the gas industry by expanding its scale on the basis of consolidating its distribution business, while focusing on operational efficiency. By optimising the entire value chain and introducing lean management and digital tools, the Group has reduced costs and improved efficiency, enhanced customer stickiness, and maximised profitability while ensuring safe supply, thereby strengthening corporate resilience and endogenous growth momentum. We firmly believe that the dual drive of scale and efficiency will promote steady growth in the gas distribution business and support the green transition.

The Group will continue to ensure the safe and efficient operation of its gas business, and guarantee the gas supply for people's livelihood. It will also actively develop industrial gas, expand its market share and follow government policy guidelines to achieve the sustainable development of the Group's gas business featuring healthy, orderly and safe.

Other Business

The introduction of third-party professional management of food ingredients and FMCG business may help explore new markets, introduce efficient processes, reduce operating costs, effectively enhance business profitability, and achieve mutual benefit and win-win outcomes.

燃氣分銷業務 (續)

本集團緊抓燃氣行業發展機遇，在鞏固分銷業務基礎上拓展規模，同時聚焦運營效益。通過優化價值鏈全流程，引入精益管理與數字化工具，降本增效、增強客戶粘性，在保障安全供應的前提下實現利潤最大化，從而提升企業韌性與內生增長動力。我們堅信，規模與效益雙輪驅動將推動燃氣分銷業務穩步增長，助力綠色轉型。

1. GENERAL INFORMATION

Chinese People Holdings Company Limited (the “**Company**”) is incorporated and domiciled in Bermuda as an exempted company with limited liability on 13 November 1996. On 24 April 1997, the Company’s shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”). The address of the registered office and principal place of business of the Company are disclosed in the section headed “Corporate Information” of the Company’s interim report.

In the opinion of the Directors, the immediate holding company of the Company is Lofty Key Limited, incorporated in the British Virgin Islands with limited liability, the ultimate holding company of the Company is Civios Group Limited, incorporated in the British Virgin Islands with limited liability, and the ultimate controlling party of the Company is Dr. Mo Shikang, who is also the chairman and an executive Director of the Company.

The Company acts as an investment holding company. The Group is principally engaged in (i) piped gas transmission and distribution, including the provision of piped gas, construction of gas pipelines and the operation of city gas pipeline network, (ii) cylinder gas supply, (iii) distribution of gas and (iv) the other business.

The unaudited condensed consolidated financial statements are presented in Renminbi (“**RMB**”), which is also the functional currency of the Company and its subsidiaries (collectively referred to as the “**Group**”).

2. BASIS OF PREPARATION AND PRINCIPAL ACCOUNTING POLICIES

The unaudited condensed consolidated financial statements has been prepared in accordance with Hong Kong Accounting Standard (“**HKAS**”) 34 “Interim Financial Reporting” issued by the Hong Kong Institute of Certified Public Accountants (“**HKICPA**”) as well as with the applicable disclosure requirements of Appendix 16 to the Rules Governing the Listing of Securities (the “**Listing Rules**”) of the Stock Exchange.

1. 一般資料

中民控股有限公司(「**本公司**」)於1996年11月13日於百慕達註冊成立為獲豁免有限公司。於1997年4月24日，本公司之股份於香港聯合交易所有限公司(「**聯交所**」)主板上市。本公司註冊辦事處及主要營業地點之地址於本公司中期報告之「公司資料」一節內披露。

董事認為，本公司之直接控股公司為崇鍵有限公司，彼於英屬維爾京群島註冊成立之有限責任公司，本公司之最終控股公司為犀楚集團有限公司，於英屬維爾京群島註冊成立之有限責任公司，本公司之最終控股方亦為本公司主席及執行董事莫世康博士。

本公司為一間投資控股公司。本集團主要在中華人民共和國(「**中國**」)從事(i)管道燃氣輸配，包括供應管道燃氣、興建燃氣管道及經營城市燃氣管道網絡；(ii)罐裝燃氣供應；(iii)燃氣分銷及(iv)其他業務。

未經審核簡明綜合財務報表以人民幣(「**人民幣**」)呈列，人民幣亦為本公司及其附屬公司(統稱「**本集團**」)之功能貨幣。

2. 呈列基準及主要會計政策
